











STAFF RECOMMENDED CONCEPT

PROPOSED CONSTRUCTION OPTIONS

Option A

- Two phase Design-Build contracting
 - Phase 1: Undercrossing segment only prior to Caltrain Electrification overhead wire installation
 - Phase 2: Ramps, stairs, landscaping
- Undercrossing open in 2022

Option B

- Single phase Design-Bid-Build contracting
- Entire project constructed at same time
- Undercrossing open in 2022 (pending requirements for Caltrain Electrification construction)



RAVENSWOOD AVENUE RAILROAD CROSSING PROJECT STATUS



- February 2019 City Council adopted 2019 Work Plan, prioritized Middle Avenue Pedestrian and Bicycle Crossing project
- March 5, 2019 City Council approved Project Study Report with Alternative C, Hybrid grade separation option
- On-going Reimbursement invoicing for San Mateo County Transportation Authority Grant funds
- Next steps
 - Draft scope of work for additional studies
 - Development of scoring criteria per Rail Subcommittee direction
 - Schedule pending Middle Avenue Crossing project schedule
