D. CONSENT CALENDAR

- 1. Approve audited bills for period 2 ending July 12, 2002 and pay period 14 ending June 29, 2002.
- 2. Authorize the City Manager to enter into an agreement with Ferreira Services, Inc. (FSI) in the amount of \$46,236 for renewal of the contract for preventive maintenance and repair services to maintain the heating, ventilating and air conditioning systems in City buildings, and authorize an option for two additional years.
- 3. Declaration of vacant position on the Las Pulgas Committee.

- 4. Community Development Agency (1) award of contract for the construction of the Belle Haven overall street improvements project to O'Grady Paving, Inc. in the amount of \$1,905,832.80; and (2) authorization of a budget of \$2,400,000 for construction, contingencies, testing, engineering, inspection and administration.

- 7. Approval of the first amendment to the lease between the City of Menlo Park and the Menlo-Atherton Cooperative Nursery School for property located at 802 Middle Avenue to limit the lessee's indemnification.
- 8. Approval of an increase in the Project Budget for the 2001-02 Sidewalk Repair Project from \$304,290 to \$409,290 to include the concrete, asphalt and drainage work for the Traffic Safety and Management Plan for the Middle Avenue and Oak Knoll School area and to complete work for the 2001-02 Sidewalk Repair Program. Appropriate \$60,000 from the 2002-03 Sidewalk Repair Program and \$20,000 from the Storm Drain Program CIP (Capital Improvement Program). Authorization of staff to amend the contract with JJR Construction in the amount of \$105,000. Resulting in a total contract of \$349,287.
