Authorization for the City Manager to enter into Master Professional Agreements with ICBO Plan Check Services; Independent Code Consultants; Kutzmann Associates; Linhart, Peterson Powers Associates; John J. Heneghan, Consulting Geotechnical and Civil Engineer; and PMC Associates for a 24 month period for the purpose of continuing the provision of contract plan check, and inspection services on an as needed basis to the staff of the Building Division in a total amount for all agreements, not to exceed \$295,000 for fiscal year 2002-03.
