    - retaining talent within the organization
- Maintain the organization's ability to meet Council goals
- Maintain long-term focus / prepare for recovery opportunities
- Maintain existing infrastructure to avoid higher costs in the future
  - Delay new projects not considered to have detrimental impacts in the short term
- Approve a 2009-2010 budget moving the City toward a sustainable budget over the next five years
