Statement from Closed Session: The Council met with city labor negotiators to discuss the existing Police Officers Association, Police Management Association and the expiring American Federation of State, County and Municipal Employees, Service Employees International Union contracts and all unrepresented employees with the purpose of providing direction to achieve reduced annual labor expenditures. Council recognized these challenging economic times and was united in directing labor negotiators to take a collaborative approach with all employees to address the opportunities to reduce labor costs for the 2009/2010 budget as well as the 2010/2011 budget. While no final decision was reached the Council provided direction to the city negotiating team to emphasize efforts to avoid layoffs and service reductions and any realignments which would best meet the service demands of the community.

**Action:** Moved, and seconded (Fergusson/Cohen) to table the item until the report returns from the Recreation Commission - Motion withdrawn.

**Action:** Moved, (Fergusson) to table this with the understanding that the Park & Recreation Commission recommendation come back to the City in a reasonable amount of time. There was no second to the motion.

**Action:** Moved and seconded (Boyle/Robinson) and passes 4-1 (Fergusson dissenting) to adopt the Master Fee Schedule for the Menlo Children's Center program for fiscal year 2009/2010.

 Consideration of two distinct acquisition and rehabilitation programs in Menlo Park, including a resolution reserving \$2.5 million of the Below Market Rate (BMR) housing fund for use in the programs, and review of and direction on a program designed to prevent pending foreclosures (<u>Staff Report #09-061</u>) (<u>Frequently Asked Questions</u>)

**Action:** Moved and Seconded (Fergusson/Cohen) to adopt a resolution authorizing two distinct acquisition and rehabilitation programs plus providing direction to staff to investigate the EARN Program.

Friendly amendment by Robinson (accepted by the mover) to involve the Housing Commission in the development and evaluation of the Foreclosure Prevention program.

It was decided to take the item in three motions.

**Action:** Moved and Seconded (Fergusson/Cohen) and passed unanimously to adopt Resolution 5852 authorizing the designation of \$500,000 from the BMR Housing Fund for the Habitat for Humanity acquisition and rehabilitation program and authorize staff to proceed with implementation of the program.

**Action:** Moved and Seconded (Fergusson/Cohen) and passed 4-1 (Boyle dissenting) to adopt Resolution 5853 authorizing staff to move forward with the Menlo Park Neighborhood Stabilization Program and authorize the city to dedicate \$2 Million from the BMR Housing Fund for the implementation of the program.

**Action:** Moved and Seconded (Fergusson/Cohen) and passed unanimously to authorize staff to proceed with using the Housing Commission to evaluate the "EARN" program ideally without the affordability restrictions, but with affordability restrictions if necessary. The Council requested periodic reporting on the City's Habitat program and the Neighborhood Stabilization Program and to work closely with the Housing Commission in the development of the Foreclosure Prevention Program.

3. Provide direction to staff regarding optional services to be negotiated with Norcal Waste Systems for inclusion in the Menlo Park Franchise Agreement for collection of recyclables, organic materials and solid waste (Staff Report #09-064) (PowerPoint Presentation)

**Action:** Moved and seconded (Fergusson/Cline) and passed unanimously confirming the use of default recycling and waste collection containers for residences including colors and sizes and directing staff to work with South Bayside Waste Management Authority (SBWMA) to negotiate with Norcal Waste Systems (Norcal) to include additional excess waste pick-ups and events and residential customer billing in the Menlo Park Franchise Collection Services Agreement.
