Action: Motion and second (Fergusson/Cline) and passed unanimously to close the Public Hearing.

Council discussion ensued.

Action: Motion and second (Cline/Fergusson) and passed unanimously to adopt the proposed Redevelopment Implementation Plan for the Las Pulgas Community Development Project Area, FY 2009/2010 - FY 2013/2014 and to include an appendix with future potential projects.

1. Provide direction to staff concerning preferred development parameters for the Hamilton Avenue East project site (<u>Staff report # 09-159</u>)

Staff presentation by Housing Manager Doug Frederick

Public comment on the item:

- Anne Moser (Housing Commission Chair) the timing of the appointment to fill the current vacancy on the Housing Commission; very strong opinion that any decision made prior to hearing from the Belle Haven community is premature; various nonhousing options were discussed including a branch library, police sub-station and pharmacy.
- Natalie Petrini Pending details on the Hamilton East property Habitat for Humanity would be interested in developing the housing
- Jim Calhoun –He handed the Council an inclusive proposal at the meeting
- Paul Angelo Adjacent property (owner occupied); nobody from the City has contacted him

Questions for the Council:

Should the affordability requirement for the project presented to the community for consideration reflect the ABAG targets? If not, should the project be more or less accommodating of very low and low income households?

Consensus of Council was to use the ABAG targets

What minimum and maximum acceptable densities should be presented to the community for consideration?

Should a mix of densities along the potential project site be considered during the community input? Should retail be included?

Consensus of Council was to look at a mix of densities, including retail

Should other "public service uses" be considered? Consensus of Council was to consider public service uses

2. Authorize the City Manager to revise the 2009-10 operating budget to reflect appropriate changes in General Fund personnel costs (<u>Staff report #09-157</u>)

Staff presentation by City Manager Glen Rojas

Action: Motion and second (Boyle/Cline) and passed unanimously authorizing the City Manager to revise the 2009-10 operating budget to reflect appropriate changes in General Fund personnel costs with strong emphasis that these are one time changes.

3. Adoption of a Resolution approving the City Council subcommittee recommendations regarding the allocation of 2009-10 community funding in the amount of \$80,000 (<u>Staff report #09-158</u>)

Staff presentation by Finance Director Carol Augustine

Motion and second (Fergusson/Cline) which passed unanimously approving **Resolution No. 5894** reflecting the City Council subcommittee recommendations regarding the allocation of 2009-10 community funding in the amount of \$80,000 and directing staff to work with the

subcommittee and consider returning at goal setting or mid-year budget review with the possibility of additional funding.

4. Approval of a High Speed Rail Project Community Outreach Plan for Menlo Park to be administered by the California High Speed Rail Authority (*Staff report # 09-149*)

Community Engagement Manager Cherise Brandell introduced Mike Garvey, consultant with HNTB, the firm selected to design the Peninsula segment.

Action: Motion and second (Cline/Boyle) which passed unanimously approving a High Speed Rail Project Community Outreach Plan for Menlo Park to be administered by the California High Speed Rail Authority.

 Approval of a letter to the California High Speed Rail Authority commenting on the Draft Alternatives Analysis for the San Francisco to San Jose segment (<u>Staff report # 09-161</u>)

- Martin Engel Spoke in support of the letter but thought it should be stronger and clearer, leave Union Pacific alone and put CalTrain and HSR below ground

Action: Motion and second (Robinson/Fergusson) which passed 3-1 (Boyle dissenting) approving the letter to the California High Speed Rail Authority commenting on the Draft Alternatives Analysis for the San Francisco to San Jose segment with the removal of the sentence in the third to the last paragraph beginning with "Essentially this...".
