Action: Motion and second (Cohen/Fergusson) to approve **Resolution 5915** adopting revised Below Market Rate Housing Program Guidelines with the condition that the document be reviewed by the Housing Commission to address Councilmember Boyle's questions and brought back to Council at a future meeting if needed passes 4-1 (Boyle dissents).

- Emily Lehr, Tobacco Education Coalition, spoke in support of the ordinance and offered assistance
- Jose Ceja spoke in support of the ordinance
- Joshua Howard, Tri-County Apartment Association, expressed concern regarding outreach to apartment owners and requested clarifications on several items in the ordinance and a 6-month phase in of the ordinance

Action: Motion and second (Fergusson/Robinson) to introduce an ordinance amending the City's smoking regulations and prohibitions and an ordinance adding tobacco retailer permitting requirements to the City of Menlo Park Municipal Code pursuant to staff's recommendation passes 4-1 (Boyle dissents) with the revisions recited into the record as follows:

- Amend section 7.30.030 regarding unenclosed areas
- Amend section 7.30.090 regarding adversely impacted parties
- Amend sections 7.30.040 and 7.30.090 regarding liability of landlords
- Delete section regarding signage
