Action: Motion and second (Robinson/Fergusson) to approve the Consent Calendar passes unanimously.

E. PUBLIC HEARINGS

Staff presentation by Revenue and Claims Manager John McGirr for the first three Public Hearing items.

The Public Hearing was opened:

 Elias Blawie spoke against the residential garbage rate increase and questioned some of the reasons the rates are being raised **Action:** Motion and second (Robinson/Fergusson) to close the Public Hearing passes unanimously.

1. Adoption of a Resolution approving rate increases in solid waste collection rates, effective retroactively to January 1, 2010, of 28 percent for all Menlo Park commercial and multi-family residential customers (Staff report # 10-037)

Action: Motion and second (Robinson/Cohen) to approve **Resolution 5918** approving rate increases in solid waste collection rates, effective retroactively to January 1, 2010, of 28 percent for all Menlo Park commercial and multi-family residential customers passes 4-1 (Cohen dissenting).

2. Adoption of a Resolution defining the service area for all single-family residences and approving rate increases in solid waste collection rates for all Menlo Park single-family residential customers effective July 1, 2010 (*Staff report # 10-037*)

Action: Motion and second (Robinson/Cohen) to approve **Resolution 5919** defining the service area for all single-family residences and approving rate increases in solid waste collection rates for all Menlo Park single-family residential customers effective July 1, 2010, passes 4-1 (Cohen dissenting).

3. Adoption of a Resolution authorizing the City Manager to submit an application form to the South Bayside Waste Management Authority authorizing the City to commit to participate in the Household Hazardous Waste, Universal Waste, Electronic Scrap, Sharps and Medicine Door-To-Door Collection, Recycling and Disposal Service with Curbside Inc. and charging \$0.20 to all multi-family residential customers and \$0.45 all single-family residential customers per customer per month with an effective date no earlier than July 1, 2010 including the provision for annual rate increases based on changes in the Consumer Price Index (Staff report # 10-037)

Action: Motion and second (Robinson/Cohen) to approve Resolution 5920 authorizing the City Manager to submit an application form to the South Bayside Waste Management Authority authorizing the City to commit to participate in the Household Hazardous Waste, Universal Waste, Electronic Scrap, Sharps and Medicine Door-To-Door Collection, Recycling and Disposal Service with Curbside Inc. and charging \$0.20 to all multi-family residential customers and \$0.45 all single-family residential customers per customer per month with an effective date no earlier than July 1, 2010 including the provision for annual rate increases based on changes in the Consumer Price Index passes 4-1 (Cohen dissenting).

 Adoption of a Resolution amending the City's Master Fee Schedule to incorporate proposed changes in fees to become effective immediately or July 1, 2010 or as required by statute for the following departments: Administrative Services, Community Development, Community Services, Library, Police, and Public Works (Staff report # 10-038)

Staff presentation by Finance Director Carol Augustine.

- Rich Ferrick, representing Menlo Atherton Little League, requested the Council consider the work that the League has done to the fields be used as an offset

Action: Motion and second (Robinson/Fergusson) to close the Public Hearing passes unanimously.

Action: Motion and second (Robinson/Cohen) to approve **Resolution 5921** amending the City's Master Fee Schedule to incorporate proposed changes in fees with the following modifications

to become effective immediately or July 1, 2010 or as required by statute for the following departments: Administrative Services, Community Development, Community Services, Library, Police, and Public Works, passes unanimously.

Modifications:

- Belle Haven School Age Child Care Afterschool Program per month fee Resident:
 - o Kindergarten through 5th grade (subsidized) Extremely low income new fee \$60
 - Kindergarten through 5th grade (subsidized) low income new fee \$100
- Belle Haven School Age Child Care Camp Programs Resident:
 - o 2 Week Program
 - o Kindergarten through 5th grade (subsidized) Extremely low income new fee \$90
 - o Kindergarten through 5th grade (subsidized) low income new fee \$130
 - 1 Week Program
 - o Kindergarten through 5th grade (subsidized) Extremely low income new fee \$45
 - Kindergarten through 5th grade (subsidized) low income new fee \$65
- Athletic Field Usage Natural Turf Non Profit Groups
 - o Baseball/Softball Youth resident new fee \$8
 - Soccer Youth resident new fee \$13
- Encroachment Permits:
 - Appeal of Encroachment Permit to City Council new fee \$110
- Heritage Tree Permits:
 - Appeals new fee \$150 for first tree, \$50 for each additional tree to a maximum of \$250
- Exclusion of the Community Development Department Subsequent Appeals and Non-Resident Appeals fee

Action: Motion (Fergusson) to amend the motion to have the artificial turf fees implemented over a two year period. With no second, the motion dies.

Action: Motion and second (Robinson/Cohen) to make no change to the current Community Development Department Subsequent Appeals and Non-Resident Appeals fee of \$110 passed 4-1 (Boyle dissenting).

Action: Motion (Boyle) to have the Community Development Department Subsequent Appeals and Non-Resident Appeals fee increase to \$220. With no second, the motion dies.
