- Action: Motion and second (Fergusson/Robinson) to proceed with consolidating the recruitment of city commissions with a staggering 2-2-2-1 schedule with appointments being made over the course of several meetings passes 4-1 (Boyle dissenting).
- Action: Direction given to staff to talk to the three Planning Commissioners appointed earlier tonight to see if one is willing to serve for only 3 years, versus having a full four year term and report it back to the Council.

Public Comment regarding the Housing Commission portion of the report:

- Anne Moser, member of the Housing Commission, spoke against reducing the number of commissioners and to allow the commission to discuss the matter prior to a Council decision
- Action: Motion and second (Boyle/Fergusson) to continue the item to a future meeting after the item has been taken to the Housing Commission passes unanimously.
  - 3. Consideration and adoption of a General Fund Reserve (unassigned fund balance) Policy; Establishment of assignments of fund balance in the General Fund; Establishment of a new Capital Improvement Projects Fund (<u>Staff report #10-56</u>)

- Action: Motion and second (Robinson/Boyle) to continue the item to a future meeting to be determined by the Mayor and Vice Mayor passes unanimously.
  - 4. Consideration of state and federal legislative items, including decisions to support or oppose any such legislation, and items listed under Written Communication or Information Item

G. Rojas discussed AB2531 which gives local redevelopment agencies specific and unambiguous authority to use tax increment for economic development purposes in order to enhance job opportunities. If approved, AB 2531 would allow the tools of redevelopment to be used more directly in creating new jobs and assisting businesses. It has the potential to act as both a short-term and long-term economic stimulus program to get California's economy moving again. Unlike other economic stimulus programs, it has the added advantage of being able to be used immediately because redevelopment agencies and staffs are already in place statewide to implement the new programs authorized by the legislation.

Action: Motion and second (Robinson/Fergusson) to authorize the City Manager and Mayor to send a letter as soon as possible to the Assembly Housing and Community Development Committee in support of AB2531 passes 4-0-1 (Boyle abstaining).
