

CITY COUNCIL COMMUNITY DEVELOPMENT AGENCY SPECIAL AND REGULAR MEETING MINUTES

Tuesday, December 14, 2010 at 5:30 p.m. 701 Laurel Street, Menlo Park, CA 94025 City Council Chambers

Mayor Pro Tempore Keith called the meeting to order at 5:33 p.m. with Council Member Fergusson absent. Council Member Fergusson arrived at approximately 5:50 p.m. due to representing City before the San Francisco Public Utilities Commission.

Public comment

- Edward Moritz urged the Council to have labor negotiations in open session.
- Mary Gilles asked what law prohibits the negotiations from being done in public.
- Barbara Hunter requested that Measure L not be diluted.
- James Salsman recommended the Council write to the senate asking for relief under the Multi-Lateral Tax Haven Treaty.
- Henry Riggs stated that if negotiations could not be done in public that he would like to see the agenda expanded to provide enough information so the public knows what is being discussed.
- Hank Lawrence would like negotiations postponed until significant public comment is allowed, including a 30 day comment period allowing the public to write in their concerns. He urged the Council to have all negotiations in public.

Glen Rojas, City Manager, explained the purpose of the Closed Session tonight is not to secure any specific direction or approval regarding the City's negotiating position, but for staff to provide the Council with information about the impasse, the City's past negotiating authority, legal requirements and implications of the upcoming meetings with SEIU, and to determine what additional information the Council might need. The Council will be asked to consider and provide direction on what public information/process to pursue before providing any specific direction to the negotiating team.

B. McClure, City Attorney, pointed out that Charles Sakai, labor negotiator would be joining the closed session once he gets through traffic. He stated that there will be no member or representative of SEIU present during closed session.

The Council adjourned into closed session at 5:41 p.m.

The regular session of the City Council was called to order at 7:08 p.m. with all members present.

Pledge of allegiance was led by Mayor Pro Tem Keith.

REPORT FROM CLOSED SESSION

B. McClure, City Attorney stated there were several members of the public present to provide comments prior to Closed Session. Charles Sakai, labor negotiator was present for the closed session items.

Item 1: Labor Negotiations with the Service Employees International Union Local 521 (SEIU):

- The City Council was presented with a lot of information and spent a lot of time being updated regarding the impasse reached last year.
- The Council received information regarding labor terms that were implemented or imposed by the City Council in May of this year.
- The Council received information about some of the terms that were implemented and received information on negotiations and the negotiations process.
- The Council did not make any specific decisions or provide any direction or authorize any specific negotiations for SEIU.
- The Council did decide to appoint a sub-committee of the to-be-elected Mayor and to-beelected Vice Mayor to work with the City Manager to determine the process, including a public process for ongoing labor negotiations.

Item 2: Threatened ligitation by SEIU and AFSCME challenging approval of Measure L, Pension Reform Initiative, adopted by voters at the November 2010 General Election:

• The City Council voted unanimously that if and when the City is sued in connection with the passage of Measure L, the City will vigorously defend the litigation.

<u>Sharon Park Homeowners Association</u>: Sharon Park Homeowners Association for the exceptional stewardship, care and preservation of more than 200 heritage trees.

<u>The Dailey Method</u>: The Dailey Method, an exercise studio, for numerous green renovations such as high efficiency fluorescent lighting with motion sensors, low VOC paint and bamboo towels.

Public Comments (for items S1 and S2)

- Mary Gilles expressed concern with the apparent backroom negotiations and the need for the Council to regain the trust of the citizens.
- Edward Moritz spoke regarding the Brown Act violation and the need to have an outside and independent investigation of the violation. The best person for the position of Mayor should be appointed.
- Heyward Robinson stated his support for Rich Cline as Mayor.
- Roy Thiele-Sardina stated that if the policy had been followed there would have been no backroom negotiations. Kelly Fergusson could resign from City Council to have the Council regain some trust within the community.
- Frank Carney stated that Kelly Fergusson should not resign. He suggested that this policy be addressed and revised in January or February.
- Steve Schmidt expressed support for Kelly Fergusson remaining on Council. Potential violations should be taken to the City Attorney and not an outside party. Mr. Schmidt encourages the Council to inform the public who they talked to regarding any item.
- Michael Francois stated Kelly Fergusson represents the City well when attending other meetings and he supports Rich Cline as Mayor.
- Don Barnby stated his support for Andrew Cohen as Mayor.
- Henry Riggs stated the Council should select a mayor that is best qualified.
- Sandy Carter stated her support for Kirsten Keith as Vice Mayor.
- Paula Maurano stated her support for Rich Cline as Mayor and Kirsten Keith as Vice Mayor.
- Vincent Bressler stated that he would like the Council to disclose who they have talked to regarding any item prior to taking action.
- Deborah Conrad stated her support for Rich Cline as Mayor and Kirsten Keith as Vice Mayor.
- Courtney Troxel stated her support for Kirsten Keith as Vice Mayor.
- Liz Pounders stated her support for Kirsten Keith as Vice Mayor.
- Mark Flegel stated the Council should follow policy.
- Sanjay Saigal stated he would like to know exactly what happened and what is going to be done
 about it.
- James Salsman hopes that the Council would use a ranked choice method for selecting a Mayor.
- Rick Ciardella stated that a Brown Act violation should be investigated by the District Attorney not the City Attorney. The selection of Mayor should be based on who is best qualified.
