**F1.** Review of Planning Commission recommendations on the Draft El Camino Real/Downtown Specific Plan (Mtg. 4) (<u>Staff report #11-168</u>) (<u>PowerPoint</u>) (<u>PowerPoint</u>2) Staff presentation by Thomas Rogers, Associate Planner

## **Public Comments:**

- Michael DiMartino spoke in support of having auto dealerships on El Camino Real.
- Anne Moser spoke regarding housing in the downtown and requested it be included in the plan.
- Deborah Miller spoke regarding the shift on development that will occur if the Specific Plan is approved.

- Lawrence Zaro spoke regarding the vacant stores on Santa Cruz Avenue as well as the parking assessments previously paid by business owners.
- Pat White spoke against the plan.
- Chuck Kinney spoke in support of the plan and the extended process. He addressed housing and parking being accommodated in Parking Plaza 2. (Handout)
- Patty Boyle spoke regarding affordable housing and the density of housing downtown.
- Jo Eggers spoke in support of accessible parking and suggested other locations to consider for parking in the downtown area.
- Richard Draeger, on behalf of the Menlo Park Downtown Alliance, spoke to the parking situation in the Plan. (<u>Handout</u>)
- John Sobrato urged the Council to approve the Specific Plan. He made suggestions regarding the height requirements and density.
- John Conway urged the Council to relax density, housing issues and permit processing.
- John Kadvany made three (3) suggestions to the Council.
- Patti Fry addressed many items contained in the document, including public benefit and housing.
- Vince Bressler spoke regarding the public benefit ad-hoc committee and the document he presented at the previous meeting.
- John Donahoe, representing Stanford University, spoke regarding the property that Stanford owns on El Camino Real. Stanford requested that the Council maintain the 45 foot height and addressed the bike trail system that is being suggested. (<u>Handout</u>)
- Chuck Bernstein proposed alternatives for the Council to consider. (Handout)
- Richard Li stated the Plan is incremental to the downtown core and requested the Council continue with adoption of the Plan.
- Adina Levin spoke regarding the possibility of adding bicycle lanes to El Camino Real and requested that El Camino Real not be increase to three lanes.
- Jeff Warmoth stated it is important to adopt the Plan to provide property owners with clarity to set expectations for development.
- Jennifer Pollock made suggestions for downtown that would include housing, retail, and restaurants for people to gather.
- David Speer requested the Council to consider the fiscal impact of the Plan and to maintain the village character.
- Jeff Pollock stated that Menlo Park has a unique opportunity.
- Bob McIntire spoke in favor of projects with density.
