proposed title of the ordinance to be edited to include the words "Sensitive Information", to read "Non-Cooperation with Sensitive Information Registry".

- 2. Ordinance adding Chapter 2.60 of the Menlo Park Municipal Code [Non-Cooperation with Sensitive Information Registry] 2.58.030 Section A1 (page 235 of the staff report) remove the words "or other sensitive information", as it was deemed redundant, to read: "Compel an individual to identify, investigate, disseminate or otherwise gather sensitive information, including information regarding an individual's religious belief, race, or nation of descent for the purpose of providing information to a national registry or national database or other sensitive information specifically used to identify individuals on the basis of sensitive information. "
- Resolution supporting immigration reform (page 245 of the staff report) replace the words "fiscal impact on state governments" with "fiscal impact on city governments", to read "(4) a funding stream to address the entire fiscal impacts on city governments."

ACTION: Motion and second (Cline/Ohtaki) to introduce an ordinance adding Chapter 2.60, Non-Cooperation with Registry, to the Menlo Park Municipal Code, with the above requested edits, passed 4-0-1 (Carlton absent).

ACTION: Motion and second (Cline/Mueller) to introduce an ordinance adding Chapter 2.58, Safe City, to the Menlo Park Municipal Code to limit cooperation with Immigrations and Customs Enforcement (ICE) and to include annual report on any incidents relevant to the ordinance, passed 3-1-1 (Ohtaki dissents; Carlton absent).

J2. Appoint a City Council Subcommittee to assist with the potential revisions to the 2016 California Green Building Standards Code - Electric Vehicle Chargers and possible direction on the level of public outreach (Staff Report# 17-110-CC)

Proclamation HONORING Ruben Niño

WHEREAS, Ruben Niño was hired by the City of Menlo Park as an Assistant City Engineer on March 21, 1988 and held the Director of Engineering Services position from March 11, 1993; and

WHEREAS, Ruben Niño was appointed to the Assistant Public Works Director position on August 21, 2006 in the Public Works Department; and

WHEREAS, Ruben Niño led the Engineering Division, paving the way for numerous capital improvement projects that helped enhance the quality of life for residents and visitors of the City of Menlo Park, including all major recreation facility improvements since working on the first master plan process in 1999 and on such projects as the new Menlo Children's Center, the Arrillaga Gymnasium and Gymnastics Centers, Kelly Park, Burgess pool renovation, the turf field at Hillview, and other improvements; and

WHEREAS, Ruben Niño worked closely with local community groups to turn dreams into realities such as Trees for Menlo to plant hundreds of London Plane trees along El Camino Real and the Menlo Park Rotary Club to create the Belle Haven Community Garden; and

WHEREAS, Ruben Niño helped create the first dog parks in the City of Menlo Park in the early 2000s, made it possible for gymnastics to be held in a tent for a whole year; and

WHEREAS, Ruben Niño led the implementation and construction oversight of the 145-home Vintage Oaks subdivision on Middlefield Road; facilitated planning, design and construction of public improvements associated with development projects including Menlo Gateway, Anton Menlo and Greystar on Haven Avenue, and many others; and

WHEREAS, Ruben Niño facilitated countless community input processes on everything from emergency water wells to field renovations to restroom upgrades to detailed design of Woodland Avenue speed bumps to full street redesigns; and

WHEREAS, Ruben Niño's dedication to the City of Menlo Park has kept residents safe during storms and emergencies, including the San Francisquito Creek flood of 1998; and

WHEREAS, Ruben Niño mentored hundreds of engineering and maintenance staff throughout his career for the City of Menlo Park; and

WHEREAS, Ruben Niño loves Hawaiian shirts and root beer; and

WHEREAS, Ruben Niño has always placed the interests and needs of the overall community first.

SAFE CITY, NON-COOPERATION WITH REGISTRY & IMMIGRATION REFORM

City Council <u>May 23,</u> 2017

BACKGROUND

January 24, 2017

- 1. City Council unanimously approved a supportive and inclusive community resolution
- 2. City Council considered Council Member Mueller's draft ordinance prohibiting the use of city resources to aid in the creation of a registry based on religious belief
- 3. City Council received information regarding welcoming cities
- 4. City Council directed staff to bring back more information on "sanctuary" cities, a draft ordinance and a welcoming city resolution

April 18, 2017

- 1. City Council received information regarding "sanctuary" cities
- 2. City Council unanimously adopted a welcoming city resolution
- 3. City Council unanimously supported Senate Bill 54, California Values Act
- 4. City Council considered a draft Immigration and Sensitive Information Ordinance
- 5. City Council directed staff to bring back to separate ordinances and a resolution regarding immigration reform

CRIME EXCEPTION SECTION 2.58.010(D)

Previous draft

With respect to law enforcement activities, no employee of the City of Menlo Park shall inquire about the immigration status of an individual, including but not limited to a crime victim, witness or person who calls or approaches law enforcement personnel seeking assistance, <u>unless it is necessary to investigate criminal</u> <u>activity by that individual or it is an element of the crime</u> <u>being reported</u>.

Current draft

... <u>unless it is necessary to investigate criminal activity by</u> <u>that individual</u>.

HATE CRIME

Penal Code Section 422.55(a)

"Hate crime" means a criminal act is committed, in whole or in part, because of one or more of the following actual or perceived characteristics of the victim: (3) Nationality

Penal Code Section 422.56(e)

"Nationality" includes citizenship, country of origin or national origin.

COOPERATION POSSIBLE SECTION 2.58.020(B)

The City of Menlo Park shall not cooperate with any request by Immigration and Customs Enforcement (ICE) to detain an individual for suspected violations of federal civil immigration law. <u>Notwithstanding the foregoing, the City may cooperate with an ICE civil detainer</u> <u>request if one or more of the following apply:</u>

- 1. The individual has been convicted of a serious or violent felony offense for which the individual is currently in custody. For purposes of this Chapter, a serious felony is any felony listed in subdivision (c) of Section 1192.7 of the Penal Code and violent felony is any felony listed in subdivision (c) of Section 667.5 of the Penal Code.
- 2. The individual has been convicted or a serious of violent felony within 10 years of the request or was released after having served a sentence for a serious or violent felony within five years of the request.
- 3. The individual has been convicted of a homicide.
- 4. The City is aware either directly or through a criminal justice database that the individual has been convicted of a serious or violent offense, which if committed in California would have been punishable as a serious or violent felony.

San Francisco Ordinance 12I.3(b) & (d)

(b) Law enforcement officials may continue to detain an individual in response to a civil immigration detainer for up to 48 hours...if the continued detention is consistent with state and federal law, and the individual meets both of the following criteria:

- (1)The individual has been convicted of a Violent Felony in the seven years immediately prior to the date of the civil immigration detainer; and
- (2) A magistrate has determined that there is probable cause to believe the individual is guilty of a Violent Felony...

(d) Law enforcement officials may respond to a federal immigration officer's notification request if the individual meets both of the following criteria: (1) The individual either: (A) has been Convicted of a Violent Felony in the seven years immediately prior to the date of the notification request; or (B) has been convicted of a Serious Felony in the five years immediately prior....

Santa Clara Policy 3.54

It is the policy of Santa Clara County (County) to honor civil detainer requests from the United States Immigration and Customs Enforcement by holding adult inmates for an additional 24-hour period, so long as...the County will exercise its discretion to honor the request if one or more of the following apply:

(1) The individual is convicted of a serious or violent felony offense for which he or she is currently in custody. ...a serious felony is any felony listed in subdivision (c) of Section 1192.7 of the Penal Code and a violent felony is listed in subdivision (c) of Section 667.5 of the Penal Code.

(2) The individual has been convicted of a serious or violent felony within 10 years of the request or was released after serving a sentence for a serious or violent felony within five years of the request, whichever is later. (a) If the individual has been convicted of a homicide crime...regardless of when the conviction occurred. (b) This subsection also applies if...the individual has been convicted of a serious or violent offense which, if committed in this state, would have been punishable as a serious or violent felony.

California Values Act (SB 54) Section 7284.6(b)(4)

...nothing in this section shall prevent any California law enforcement agency from doing the following:

(4) Responding to a notification request from federal immigration authorities for a person who is serving a term for the conviction of a misdemeanor or felony offense and has a current or prior conviction for a violent felony listed in subdivision (c) of Section 667.5 of the Penal Code or a serious felony listed in subdivision (c) of Section 1192.7 of the Penal Code, provided that response would not violate any local law or policy.

Government Code Section 7282.5(a)

A law enforcement official shall have discretion to cooperate with federal immigration officials...only under the following circumstances:

(1) The individual has been convicted of a serious or violent felony identified in subdivision (c) of Section 1192.7 of, or subdivision (c) of Section 667.5 of, the Penal Code.

(2) The individual has been convicted of a felony punishable by imprisonment in the state prison.

(3) The individual has been convicted within the past five years of a misdemeanor or a felony for any of the following offenses: (A) – (AE)

(4) The individual s a current registrant of the California Sex and Arson Registry

(5) The individual is arrested and taken before a magistrate on a charge involving a serious or violent felony...and the magistrate makes a finding of probable cause.

(6) The individual has been convicted of a federal crime that meets the definition of an aggravated felony.

Alternative Language for Section 2.58.020(B)

Alternative #1

The individual has been convicted or a serious of violent felony within 10 years of the request or was released after having served a sentence for a serious or violent felony within <u>seven</u> years of the request.

Alternative #2

The City of Menlo Park shall not cooperate with any request by Immigration and Customs Enforcement (ICE) to detain an individual for suspected violations of federal civil immigration law. <u>Notwithstanding the</u> <u>foregoing, the City may cooperate with an ICE civil detainer request</u> <u>only under the circumstances identified in Government Code Section</u> <u>7282.5(a)(1) – (4) and (6).</u>

NON-COOPERATION WITH REGISTRY

CHANGES

- Limited to language regarding not using city resources to collect sensitive information to create or participate in creating a national registry

IMMIGRATION REFORM

RESOLUTION

Urges Congress to enact comprehensive immigration reform which addresses:

- 1. Earned legal residency accompanied by a clear path to citizenship
- 2. The future immigration of families and workers
- 3. Improved immigration enforcement and border security that is consistent with national values
- 4. A funding stream to address fiscal impacts on state governments
