 - Ashley Eikenberry, the permit applicant, spoke about independent arborist report that advised the tree be removed. Ms. Eikenberry raised concerns about the safety and possible property damage.

ACTION: Motion and second to approve the tree removal permit with condition to receive a report on the tree replacement, passes unanimously.
