#### F. Regular Business

F1. Direction on biennial community survey methodology and vendor (Staff Report #19-210-CC)

Public Engagement Manager Clay Curtin introduced the item.

The City Council discussed the need for statistically significant results. There was also discussion on previous experiences with the two vendors. The City Council created a subcommittee to work on the survey questions for Godbe Research and appointed City Councilmembers Carlton and Nash. City Council requested that work from the subcommittee and staff return to the City Council before being released to the public.

**ACTION**: Motion and second (Carlton/ Nash) to select Godbe Research as the vendor for biennial community survey, passed unanimously.

F2. Discussion of options for formation of re-districting committee following release of 2020 census information (Staff Report #19-207-CC)

Assistant City Attorney Cara Silver made the presentation (Attachment).

• Pamela Jones spoke in support of an independent redistricting commission and keeping the charter separate (Attachment).

The City Council received clarification on the details of an independent and advisory committee and discussed the previous advisory districting committee. The City Council supported public outreach during the districting process.

F3. Review proposed City Council procedure #CC-19-010 "City Council powers and responsibilities" and provide direction to staff (Staff Report #19-206-CC)

Assistant City Manager Nick Pequeros introduced the item and made the presentation (Attachment).

Assistant City Manager Pegueros detailed the major changes to the procedure. The City Council provided the following direction: requested that Mayor Pro Tem be included in the agenda setting, updating "Grand Boulevard Initiative Taskforce" name, add to the notes of the Caltrain Modernization Local Policy Maker Group to include Rail Subcommittee members, add to the notes of the County of Santa Clara Community Resources Group for Stanford University to include ad hoc subcommittee on Stanford General Use Permit members, encourage City Council to report out on outside board meetings during City Councilmember Reports at City Council meetings, update the Mayor Pro Tem title to Vice Mayor, and include the Willow Village/ Facebook subcommittee. The City Council requested this item be updated and returned on consent.

# **2018 TRANSITION TO DISTRICTS**

# April 4, 2018 Ordinance Transitioning to Districts

- Council adopted ordinance transitioning to district elections effective November 2018 election
- Transition motivated by threat of litigation over compliance with the California Voting Rights Act (CVRA).
- Council formed an Advisory Districting Committee to recommend boundaries
- Committee and Council explored 5 and 6 district options and ultimately selected 5 districts
- Election sequencing
  - 2018: Districts 1, 2 and 4 elections
  - 2020: Districts 3 and 5 elections





# **2018 ADVISORY COMMITTEE**

### December 4, 2017: City Council formed Advisory Districting Committee

- 9 members
- Randomly selected
- Residency and voting requirements
- Independent Committee requirements pre, during and post-service restrictions

#### Committee work

- Assisted by staff, city attorney and demographer
- Used online mapping tool
- Conducted 8 public meetings
- Presented recommendation to City Council
- City Council accepted recommendation





# **RE-DISTRICTING REQUIREMENTS**

# REDISTRICTING REQUIREMENTS



# Redistricting timing

- Every 10 years, city must adjust boundaries of districts to ensure compliance with Voting Rights Act.
- Redistricting must be November 1 of year following decennial census (i.e. November 1, 2021

# Redistricting Criteria

- Equal population
- Must comply with Federal Voting Rights Act and Equal Protection
   Clause
- Race shall not be predominate factor when drawing districts







- City Council may draw districts
- Advisory Districting Committee
  - Provides recommendation to City Council
  - City Council may impose criteria for service
- Independent Districting Committee (authorized by 2017 legislation)
  - Strict application criteria
  - Regulations regarding pre and post service
  - Must file Form 700
  - Committee's decision is final





# TIMELINE FOR IMPLEMENTATION

- April 1, 2020 -- Census day
- December 2020 Census Bureau delivers counts to president and Congress
- March 31, 2021-- Census Bureau sends redistricting counts to states
- August 1, 2021 -- Advisory Commission must provide re-drawn map to City
   Council for recommendation
- September 30, 2021-- Independent Commission must provide re-drawn map to Council
- October 31, 2021 -- City must complete re-districting process
- November 2022 Districts 1, 2 and 4 election



#### 10012019 AGENDA ITEM F:2 Discussion of options for formation of re-districting committee

Mayor Mueller, Mayor Pro Tem Taylor, Councilmembers Nash, Combs, and Carlton and Staff,

The Menlo Park City Council and staff are again to be commended for the highly successful Advisory Districting Committee established to guide our first-time mapping. We are now ready to move to the next level of inclusive and transparent redistricting.

Legislation such as SB 1108 supports general law cities establishing independent redistricting. Most recently, SB 139 was Governor Enrolled. SB 139 requires a county with more than 400,000 residents to establish an independent redistricting commission. Clearly the trend supports independent redistricting commissions at all levels of government.

There are multiple organizations that support independent redistricting commissions at all level of government. The League of Women Voter's states "We believe responsibility for fair redistricting should be vested in an independent commission." California Common Cause explicitly states "voters should pick their representatives ..." in support of local redistricting. Helen Grieco, Common Cause Northern California Organizer will be available during our process. In addition, the California Local Redistricting Project "provides educational resources and assistance to local jurisdictions interested in moving away from political redistricting towards interdependent redistricting."

The Brennan Center for Justice "supports reforming the redistricting process so that it is independent, transparent, and ensures that communities are fully and fairly represented in Congress and the nation's legislative bodies."

According to California Local Redistricting Project, "there are several reasons why jurisdictions opt to establish independent redistricting commissions:

- Increased Citizen Participation & Transparency: Citizen commissions are a direct way to involve
  the community in redistricting. Commissions are required to have more public hearings and
  provide greater notice of proposed maps than a local legislative body. Proposed district
  boundaries must be considered, debated, and adopted in public, with opportunities for community
  input at every stage of the process.
- Depoliticize Redistricting: Commissions can help depoliticize redistricting and increase public
  trust in the process. Under political control, redistricting can be a source of infighting on a
  governing board as members fight over neighborhoods or community assets. Council- or boardcontrolled redistricting can also be abused by the majority to accomplish political ends, for
  example drawing an existing member out of their district or placing two members into the same
  district.
- More Representative Districts: Compared with legislative bodies, studies find that independent commissions generally draw districts that are more compact, less gerrymandering, and more representative of communities of interest and minority populations.

It is important that the City of Menlo Park removes itself from the process of redistricting by the establishment of an Independent Redistricting Commission. Although the Advisory Districting Committee's recommendation was accepted and passed by ordinance, our future lies in a process that eliminates any possibility or inference of political interference. This can only be accomplished by citizens who will make the final decision on the establishment of districts through an independent redistricting commission.
