Mayor Taylor called the meeting to order at 5:33 p.m.

D. Study Session

D1. Receive an overview and provide feedback and guidance on the revised draft General Plan Environmental Justice and Safety Elements in preparation for the final draft documents (Staff Report #24-113-CC) (Informe de Personal #24-113-CC)

Senior Planner Calvin Chan and ChangeLab Solutions Managing Director Erik Calloway made the presentation (Attachment).

- Lynne Bramlett spoke on concerns related to balancing the Housing, Environmental Justice and Safety Elements and overall public safety.
- Pam Jones spoke on commonality of funding for the Environmental Justice and Safety Elements.
- Climate Resilient Communities Executive Director Violet Saena spoke in support of the Environmental Justice (EJ) Element and serving the Belle Haven community.
- Belle Haven Empowered and Menlo Together representative Marlene Santoyo spoke in support of the EJ Element efforts and requested updating the community feedback matrix and additional policy/program review.
- John McKenna spoke in support of continuing to listen to the needs of the Belle Haven community and to include those in the EJ Element.
- Rob Chua spoke on bio-safety levels considerations while working on the General Plan.
- Adina Levin spoke in support of clear timelines, reporting, implementation and expectations.

The City Council received clarification on the Safety Element updates to Section 7, Safety Element and EJ Element public outreach, bio-safety planning, mapping of liquefaction and soft story buildings, sea-level rise within the Elements, in/outdoor air quality reporting, lead in homes in the Belle Haven neighborhood, age range of community participants, emergency preparedness versus disaster preparedness, local hazard mitigation planning and the Safety Element, and Noise Element considerations for areas in airport flightpaths.

The City Council discussed updating the City's "hazards", funding for the EJ Element, in/outdoor air quality policy, building electrification and heat pumps, no-smoking ordinance for Downtown, focus areas for EJ Element being 1) specific matrix 2) timeline 3) prioritization/budget and an annual check-in.

The City Council took a recess at 7:36 p.m.

The City Council reconvened at 7:50 p.m.

The City Council discussed rental assistance, eviction, relocation assistance, rent control and housing priorities and potential funding through the Bayfront Mitigation Fund.

The City Council received clarification on extreme heat and natural disasters and future discussions on rent control.

The City Council directed staff:

- enhance discussion of climate change and sea-level rise in the documents
- return for a study session on life-sciences and planning for bio-hazard safety levels
- include indoor air quality discussions in the documents
- consider liquefaction and ground water mapping
- explore anti-displacement measures such as rental registry and support programs for homeowners
- refine programs/actions to 1) healthcare and healthcare resources 2) higher quality education 3) Wi-Fi 4) higher education
- partner with community based organizations
- consider hardcopy materials for outreach to households, particularly door-to-door outreach
- support cooling centers in the EJ Element
- explore having designated staff to liaison with the public for EJ Element-related issues
- consider exploration of soft story buildings
- monitor the city's efforts in the update to the Multijurisdictional Local Hazard Mitigation Plan
- explore no-smoking policy downtown
- clarify property owner responsibilities for soil remediation
- continue accessible meeting spaces for EJ Element-related topics
- simplify lists, prioritization, and overall documents funding
- evaluate transfer of \$1 million from the Bayfront Mitigation Fund to support EJ efforts
- encourage healthcare access
- consider including business districts in disaster and emergency preparedness

E1. Adopt a resolution to amend the fiscal year 2023-24 budget (Staff Report #24-114-CC)

ACTION: Motion and second (Doerr/ Nash), to adopt a resolution approving an amendment to the fiscal year 2023-24 operating and capital budget to include a one-time transfer from the General Fund (Fund 100) to the General Capital Improvement Fund (Fund 501) of \$1.75 million for projects outlined in the Capital Improvement Plan (CIP), passed unanimously.



SAFETY ELEMENT UPDATE

- Purpose: Identify how to reduce potential risks of injury, property damage, and economic and social disruptions resulting from natural and human-made hazards
- Focus: Addressing new State-required topics
 - Climate change adaptation and resiliency
 - Wildfire hazards and risks
 - Identify residential developments lacking 2+ emergency evacuation routes





REVISED DRAFT EJ ELEMENT (APRIL 24, 2024)



- A Modify certain statements about EJ context
- B Make adjustments to the refinement framework matrix
- C Continue performing and implementing robust outreach
- Think critically about funding needs and sources
- Consider actions with short-term results to demonstrate and communicate progress

COMMUNITY RECOMMENDATIONS FOR REVISED DRAFT EJ ELEMENT



Increase opportunities for accountability through strict reporting requirements on EJ Element Programs and Policies

Ensure "Safe, Sanitary, and Stable Housing" is used in Goal 5 language and throughout the document, replacing "Safe and Sanitary Homes"

Strengthen program and policy language throughout the EJ Element, for example by changing encourage to ensure or could to should/shall

Elevate Anti-Displacement Actions into the EJ Element, accelerate timelines for creation and implement interim steps as soon as possible.





FUNDING NEEDS AND SOURCES

- The EJ Element includes listing of potential funding sources
- Additional considerations regarding programs and actions:
 - Infrastructure enhancements
 - Specific sites
 - Potentially eligible for funding through special funds
- June 11: City Council expressed support for use of the Bayfront Mitigation Fund to support EJ Element programs





ACTION GUIDE (IMPLEMENTATION GUIDE)









- Action Guide includes action items to implement certain EJ programs
- Dual-document approach allows for more frequent updating of action items to respond to changes in:
 - Community needs
 - Funding opportunities
 - Ongoing community outreach, particularly from Menlo Park's Underserved Communities
- A comprehensive, re-formatted version of the Action Guide will be maintained on the City's website to improve accountability and tracking of efforts to advance EJ
 - Simplified presentation
 - Background information (grey columns) removed
 - Inclusive of all EJ programs and action items





REVISED DRAFT SAFETY ELEMENT (APRIL 15, 2024)



Policies/ programs revised to include community feedback

- Revised Policy S1.35 Disaster Preparedness Planning
 - Multilingual and multimodal outreach in Underserved Communities
- Revised Policy S1.36 Community Preparedness
 - Support countywide preparedness, response and protection services
- New Program S1.M Sea Level Rise Planning
 - Collaborate with other agencies to develop a sea level rise plan as part of a subregional San Francisco Bay shoreline resiliency plan
- No changes to Open Space/Conservation and Noise Elements





JUNE 3 PLANNING COMMISSION STUDY SESSION
