### Recognizing October as National Domestic Violence Awareness Month

**WHEREAS,** domestic violence touches all communities, affecting tens of millions of people of all genders, sexual orientations, ages, racial, ethnic, cultural, social, religious, and economic groups in the United States and here in California; and

**WHEREAS**, more than one in three women and one in four men and one in two transgender individuals experience some form of physical or sexual violence and/or stalking by their partner in their lifetime, and over 15.5 million children are exposed to domestic violence every year; and

**WHEREAS**, the marginalization of undocumented individuals, transgender individuals, and people living with disabilities, increases their vulnerability to domestic violence; and

**WHEREAS**, domestic and intimate partner violence among the most under-reported crimes, and has life-long consequences emotionally, mentally, socially, spiritually and physically; and

**WHEREAS,** domestic violence programs in California, such as Community Overcoming Relationship Abuse (CORA), provide essential, lifesaving services for survivors, their children, and communities; and

**WHEREAS**, there were 8,275 requests for service through CORA's 24-hour crisis hotline and law enforcement referrals in San Mateo County last year; and

**WHEREAS,** in San Mateo County, 94 adults and children were provided emergency shelter and 76 households were provided longer term rental assistance to escape their abusers last year, 485 adults and children received therapy to help them with domestic violence-related trauma, and CORA fielded 1,925 requests for legal assistance; and

**WHEREAS**, all communities deserve access to culturally responsive prevention programs and initiatives to improve overall community health and safety by challenging the societal norms that perpetuate violence; and

NOW, THEREFORE LET IT BE RESOLVED, that I, Cecilia Taylor, Mayor of the City of Menlo Park, on behalf of the City Council, hereby proclaim October 2024 as National Domestic Violence Awareness Month. Let us all learn to recognize signs of domestic violence, promote awareness, and honor those who have lost their lives to domestic violence.

## Recognizing October as Cybersecurity Awareness Month

**WHEREAS**, the City of Menlo Park recognizes that it plays a vital role in identifying, protecting its residents from, and responding to cybersecurity threats that may have significant impact to our individual and collective safety and privacy; and

**WHEREAS**, critical infrastructure (i.e., financial services, educational institutions, energy, telecommunications, transportation, utilities, health care, and emergency response systems) is increasingly reliant on the support of information systems and technology; and

**WHEREAS**, cybersecurity education and awareness are crucial for everyone, including large corporations, small businesses, financial institutions, schools, government agencies, non-profit organizations, the home user, and anyone who connects to the internet, be it with a computer, mobile phone, or other internet-connected device; and

**WHEREAS**, monitoring your accounts, being conscientious of what you share online, keeping computer software up to date, creating unique passwords and changing them regularly, installing antivirus programs and firewalls, and using mobile devices and other internet-connected devices safely, are ways people and organizations can protect themselves from phishing, viruses, ransomware, other types of malware, financial loss, and loss of sensitive data; and

**WHEREAS**, maintaining the security of cyberspace is a shared responsibility in which each of us has a critical role to play, and awareness of essential cyber hygiene will improve the security of the City of Menlo Park's information, infrastructure, and economy; and

**WHEREAS**, all are encouraged to reduce online risks by learning about cybersecurity so they can put that knowledge into practice in their homes, schools, workplaces, and businesses;

**NOW, THEREFORE, BE IT RESOLVED** that I, Cecilia Taylor, Mayor of the City of Menlo Park, on behalf of the City Council and the City, do hereby designate October 2024 as Cybersecurity Awareness Month.

## HISTORY OF THIS PROCESS TO DATE

- Mobile automate license plate readers (ALPRs) in operation on MPPD Police vehicles since 2013
- Study Session before the City Council in September 2023
- Follow-up Study Session Before the City Council in May 2024
  - Direction by City Council to place funding in the 2024-25 budget for Flock Fixed ALPRs
  - Flock Fixed ALPRs are approved as a 2024-25 budget item (June 2024)
- Over 4 hours of discussion and public commentary
- Extensive research into concerns of public across the national narrative
- Careful crafting of an agreement, ordinance, and policy that balance the public concern and civil rights with public safety needs







- Compliance with the statutory process for "surveillance technology."
- A proposed amended Municipal Code revised to cover the changes in operation related to implementation of Flock Technology is before you for introduction and ultimate approval.
- MPPD has drafted revisions to its ALPRs Policy.
