The City Council directed staff to:

- Relocate the proposed rapid flashing beacon at the Arbor Road intersection from the Church crosswalk to the Lyle Park crosswalk.
- Remove of the proposed rapid flashing beacon at Yale.

• Relocate the proposed speed feedback sign near the driveway to Safeway Plaza to a location further west on Middle Avenue near the Kenwood Drive intersection.

ACTION: Motion and second (Nash/ Taylor), to award a \$1,507,400 construction contract to Rapid Services, LLC dba Rapid Grading Services for the Middle Avenue Complete Streets project, approve a contingency in the amount of \$230,000 (held by the City), passed 4-0-1 (Combs absent).

RECOGNIZING FIRE MARSHAL JON JOHNSTON

WHEREAS, Jon Johnston began his career with the Menlo Park Fire Protection District (MPFPD) in July 2000 as a Fire Protection Specialist beginning with public education and completing the Bars on Windows Program; and

WHEREAS, Jon worked his way up the ranks and was promoted to Fire Inspector/Investigator, performing construction inspections, plan review, hazardous materials inspections, fire investigations and code enforcement and was promoted to Fire Marshal in 2014; and

WHEREAS, as Fire Marshal, Jon Johnston provided proactive prevention education in the community, educating homeowners on fire mitigation and home hardening techniques and established strong partnerships between the Fire District and the cities he's served using a collaborative approach and exceptional ability to find common ground; and

WHEREAS, in 25 years of service, Jon Johnston helped bring down fires to less than 2% annually, helped reduce the use of fireworks by 50%, and led UAS teams to the Tubbs Fire, Carr Fire and Camp Fire to aid in quicker recovery from devastating wildfires; and

WHEREAS, throughout his career with the MPFPD, Jon has also served with several organizations, including as the Northern CA Fire Prevention Officer Public Education Co-Chair from 2003 to 2007, Executive Board Member of the Alisa Ann Ruch Burn Foundation from 2010 to 2011, San Mateo County Fire Prevention Officers President from 2012 to 2016, Kiwanis International member and as High School Key Club advisor at Menlo-Atherton High School from 2005 to 2013; and

WHEREAS, Jon Johnston co-founded Menlo Park Relay for Life and founded the Menlo Park Fire Pancake Breakfast, which has raised over \$250,000 over 24 years. In 2009, he was awarded the Menlo Park Golden Acorn award and San Mateo County Lions Club Service award; and

WHEREAS, at the April 15 MPFPD board meeting, several colleagues and community members spoke in appreciation and celebration of Jon's numerous contributions to his community, to fire prevention education and to public safety; and

WEST BAY MODEL RAILROAD ASSOC. 75th ANNIVERSARY

WHEREAS, the West Bay Model Railroad Association (WBMRA) was founded in 1947 as a center for model railroading enthusiasts and has been in its current location near Ravenswood Avenue since 1950; and

WHEREAS, the first building served as a supply repository for the troops at Camp Fremont during World War I, accommodating the 41st National Guard Infantry Division, then the US Army 12th Infantry Division and later the US Army 8th Infantry Division and was located on the property now occupied by Menlo Schools and College; and

WHEREAS, as the former Railway Express Agency (REA) depot, the location provided the southern peninsula distribution point for package and freight and was the main way to ship packages until 1975; and

WHEREAS, from 1947 to 1950 the layout accommodated O, S and HO scale model railroads. In 2012 a new design plan was introduced with WIFI DCC (Digital Command Control) and controllers for a layout completely dedicated to HO scale trains. Construction began in 2013, and the full layout operation was completed in 2023; and

WHEREAS, over 220 community members attended the 75th Anniversary celebration of the WBMRA on March 15, 2025; and

WHEREAS, during the celebration, 6 model trains simultaneously wound their way through the three-peninsula HO landscape with 2 trains on sidings switched in every hour, and 23 members of the WBMRA operated trains, monitored the layout and conversed with visitors; and

WHEREAS, the WBMRA holds open houses every first and third Saturday of the month from 1 - 4 p.m.; donations are not required but are encouraged to help the WBMRA continue providing the HO train layout experience to the public; and

NOW, THEREFORE, BE IT PROCLAIMED, that I, Betsy Nash, Vice Mayor of the City of Menlo Park, on behalf of the City Council and City, do hereby recognize the 75th Anniversary of the West Bay Model Railroad Association.

- BART's customer satisfaction is at its highest level in 10 years. 73% of respondents are "very or somewhat satisfied with BART". Up 6% since 2022
- Crime on BART in 2024 was down 17% from 2023 and customer satisfaction has increased to its highest level in 10 years. Violent crime in SF went down 14% in the same period
- BART is running shorter trains to reduce costs and increase safety, and **added 59 public safety personnel** to stations and police cars.

Operators have made significant cuts and maximized revenues to lessen the shortfalls, totaling hundreds of millions in savings.

- Holding vacancy rates (as high as 22%)
- Defunding hundreds of positions
- Reducing fare evasion by hiring fare inspectors and installing new fare gates
- Changing service offerings to maximize ridership

• 2025 State Budget Request

- \$2 billion statewide,\$750 to Bay Area
- Bridges near term funding gaps anticipated prior to potential ballot measures

• 2026 Multi-County Measure

- Enabling legislation SB 63 (Wiener, Arreguín)
- Sales tax levy in 3-5 counties raising upward of \$560 million annually
- Funding would go to BART, MUNI, AC Transit and Caltrain + transit transformation investments
- Includes financial efficiency study requirement
- San Francisco specific revenue approaches
 - Example options presented at MUNI funding working group
 - Details still TBD
