



### Some Midpen Facts

- Public agency, created in 1972 by a grassroots voter initiative
- 763,000 constituents (2020)
- Elected board: seven directors
- Funded primarily through property tax
- 27 Preserves in Santa Clara, San Mateo and Santa Cruz counties
- Preserved over 72,000 acres, 250+ miles of trails
  - Over 15,000 acres of grazing land on the San Mateo Coast
- Preserves are free and open to the public every day of the year
- Main office in Los Altos + field offices

- Opened 3 new parking areas, creating a total of 126 new parking spaces





# Parks and Recreation Commission: Update on 2024-2025 Work Plan

### PRC work plan 2024-25 includes 11 goals



### Primary goals

- Providing a forum for public information and discussion about City park and recreation issues and facilitate robust public comment and participation at commission meetings
- Supporting and advising the recreation program development and operations of the Belle Haven Community Campus
- Reviewing progress toward the goals in the 2019 Parks and Recreation Facility Master Plan

### PRC work plan 2024-25 includes 11 goals



- Additional goals include
  - Participating in park and recreation facility tours
  - Advising on the maintenance and upgrade of recreational facilities
  - Receiving staff presentations and reports about major service areas and programs
  - Annually review departmental budget proposal
  - Reviewing public-facing recreation policies and recommending updates
  - Maintaining a 12-month schedule of planned commission agenda items
  - Review and advising on potential synergies with or support from other City departments







### Goal 1: Act as a Public Forum



- The PRC heard feedback from hundreds of commenters at multiple meetings of the PRC and at joint meetings with the Library Commission (LC). Public comments touched on a range of topics including but not limited to: aquatics, tennis and pickleball courts, athletic fields, and Bedwell Bayfront Park.
- The PRC advised the development of a citywide survey on libraries, recreation and parks in March; and reviewed the survey results in May and July.
- The PRC reviewed the results of a citywide survey on aquatics in November, 2024.





### **Goal 2: Support and Advise**



- Program development and operations of the Belle Haven Community Campus (BHCC)
- The PRC continues to receive updates on BHCC:
  - Staff presented an update regarding operations at BHCC in July.
  - Feedback from users is being collected and reviewed monthly.







## **Goal 3: Review Progress**



- Toward goals in the 2019 Park and Recreation Facility Master Plan
  - The PRC received a presentation about the athletic field allocation process in July.
  - The PRC received updates about the Kelly Park turf and track renovation project in October 2024.
  - The PRC received a presentation on parks policy enforcement in September, 2024.

# Building code local amendments

### **Background**



- The California Building Standards Code (CBSC) is updated every three years and cities are allowed to adopt local amendments
- Peninsula Clean Energy (PCE), TRC consultants, and the investor-owned utility funded statewide reach codes program team support cities in developing local amendments to the Energy Code and CALGreen



### **Options**

- 1) Expanded pre-wiring requirements(Attachment A)
- 2) Expanded pre-wiring requirements and installation of heat pump (HP) space heating equipment instead of air conditioner (AC), or installation of air conditioner with energy efficiency measures also known as AC to HP (Attachment B)
- Recommended: Expanded pre-wiring requirements and air conditioner (AC) to heat pump (HP), and flex path (Attachment C)



### Recommendation

- Consider options for amending the 2022 California Building Standards Code (CBSC), accept the cost effectiveness study, and introduce and waive the first reading of an ordinance adopting local amendments to the 2022 CBSC in Chapter 12.18 of the Menlo Park Municipal Code that include:
  - expanded pre-wiring requirements;
  - installation of heat pump space heating equipment instead of air conditioner, or installation of air conditioner with energy efficiency measures;
  - and expanded energy efficiencies for single family alterations and additions.

### **Expanded pre-wiring**

- Updates would expand existing requirements to:
  - Ensure conduits for future electric appliances are installed with electrical and other work (kitchen, laundry, garage/water heater closet)
  - Require conduit installation with outdoor gas appliances (BBQ, heaters, pool heater)
  - There are exceptions







### Air conditioner (AC) to heat pump (HP)

- Requires the installation of heat pump space heating equipment instead of air conditioner, or installation of air conditioner with energy efficiency measures;
  - There are exceptions
- Prepares residents for Bay Area Air District rules beginning Jan. 1, 2027
- Same level of cooling, with additional heating option in a single piece of equipment
  - Does not require removal of gas heating equipment





### Flex path

- Amends the Energy Code to require expanded energy efficiencies for single family alterations and additions with an estimated project cost of \$100K or more
  - There are exceptions
- Energy efficient measures and electrification:
  - Installing insulation (attic, wall, floor, around accessible hot water piping)
  - Replace fuel gas water heater with heat pump water heater
  - Complete a Home Energy Score or Home Energy Audit report and implement one or more recommendations included in report
  - Replace all screw in incandescent and CFL lamps with lamps of efficiency of 45 lumens per watt or greater

### **Edits**



- Minor formatting errors
- Section 4: Effective Date
  - This ordinance shall be in effect thirty (30) days after the date of adoption, and implemented upon the California Energy Commission's approval.
- Attachment A, B, and C
  - Under 4.106.5.1, updating section numbers to 4.106.5.**1**.1, 4.106.5.**1**.2, 4.106.5.**1**.3
- Attachment C:
  - 4.507.3 typo that reads 510 when it should read <= 5%

# **Timeline of next steps**



- After adoption, staff will file the ordinance with California Building Standards Commission
- Pre-wiring is effective 30-days after adoption
- AC to HP and flex path shall be in effect thirty (30) days after the date of adoption, and implemented upon the California Energy Commission's approval.
