Regular Business:

Consider Support for the City's application to the Safe Routes to School and Green Streets Infrastructure Pilot Program

Recommendation

Staff recommends that the Complete Streets Commission support the grant application for the Safe Routes to School and Green Streets Infrastructure Pilot Program for the Oak Grove Avenue Pedestrian Pathway (Project). The Project includes the following proposed improvements:

- Construction of a continuous sidewalk between Nativity School and Nativity Church, including along the Vallombrosa Center frontage
- Installation of curb extensions with landscaping for improved stormwater management

Policy Issues

The proposed project is consistent with policies stated in the 2016 General Plan Circulation Element. These policies seek to maintain a safe, efficient, attractive, user-friendly circulation system that promotes a healthy, safe, and active community and quality of life throughout Menlo Park.

Background

In mid-July, the City/County Association of Governments (C/CAG) of San Mateo County issued a Call for Projects for the Safe Routes to School and Green Streets Infrastructure Pilot Program. An action of support from the Complete Streets Commission will strengthen the City's application for the Project. Staff is proposing to submit an application for the construction of a continuous sidewalk between Nativity School and Nativity Church, including along the Vallombrosa Center frontage.

Analysis

The purpose of the Project is to provide pedestrian safety improvements to Oak Grove Avenue to close gaps in the existing sidewalk and to improve stormwater infiltration and drainage patterns. This Project includes construction of sidewalk and curb extensions along the project extents. This would result in improved safety and connectivity to and from Nativity School, Menlo-Atherton High School, transit stops, Nativity Church, and other destinations.

When choosing this Project for the application, City staff reviewed the list of potential grant projects that the Commission reviewed as part of prior grant program requests in July 2017. This particular grant

program requires projects to be within ½ mile of a school and must include green infrastructure elements to address stormwater. The City's Engineering and Transportation Divisions collaborated to identify areas of the City where green infrastructure needs aligned with school safety priorities. Further, the grant program has construction deadlines for project delivery that must be met which limits the complexity of projects that can be pursued with these funds. Consideration was also given to proximity to schools, high-activity areas, pedestrian and bicycle demand, cost, and transportation network gap closures.

Staff is continuing to search for funding opportunities for other projects that have been identified through resident feedback, Commission feedback, or identified by staff. Several additional grant programs are anticipated to be announced later this year. Staff has prepared a list of potential projects (Attachment A) for consideration in upcoming grant opportunities. Commission feedback on this list of potential future projects is welcome to help staff plan ahead for future grant opportunities.

Impact on City Resources

Staff resources are required to support this project. If grant funding is approved, staff will be request Council to include the projects into the Capital Improvement Program for FY 17-18, advancing the necessary funds and staff resources to take advantage of the grant funds. It may impact the timely completion of previously funded projects.

Environmental Review

The installation of these improvements are categorically exempt under Class 1 of the California Environmental Quality Act. Class 1 allows for minor alterations of existing facilities, including highways and streets, sidewalks, gutters, bicycle and pedestrian access, and similar facilities, as long as there is negligible or no expansion of use.

Informational Item:

2nd Quarter Update on 2017 City Council Work Plan

Recommendation

This is an informational item and does not require Commission action.

Policy Issues

It has been the City Council's policy to annually adopt its Work Plan, Budget Principles and Procedures Manual. The City Council adopted its 2017 Work Plan (Attachment A) on February 7, 2017. The current version of the 2017 Work Plan includes 57 items, some of which include multiple components. Many of these items are typically not funded until the adoption of the budget late in June.

Background

The City Council held a Special Meeting on January 27, 2017, at the Arrillaga Family Recreation Center to discuss and identify the work plan items for the year. The City Council approved the work plan February 7, 2017, and staff used it to help craft the fiscal year 2017–18 budget.

The Work Plan has been grouped into themes and priority levels to help categorize the items. The themes are as follows in no specific order:

- Responding to the development needs of private residential and commercial property owners
- Realizing Menlo Park's vision of environmental leadership and sustainability
- Attracting thoughtful and innovative private investment to Menlo Park
- Providing high-quality resident enrichment, recreation and discovery
- Maintaining and enhancing Menlo Park's municipal infrastructure and facilities
- Furthering efficiency in city service delivery models
- Improving Menlo Park's multimodal transportation system to move people and goods through Menlo Park more efficiently

Analysis

As of this quarterly update, a new item is being added to the work plan: Revisions to the 2016 California Green Building Standards Code. The goal of this item is to adopt increased requirements for electric vehicle chargers that would be applicable citywide. The target completion date for this item is the end of 2017.

The Public Works Department, specifically the Transportation Division, is currently working on several 2017 Work Plan items. Web link to the latest quarterly status update report on individual work plan items prepared for the August 29, 2017 City Council meeting is included in Attachment B. Transportation related work plan items include: #2, #4, #20, #44 - #56. Staff will share the next quarterly work plan status update

report with the Commission when it is made available. New project proposals not listed in the Work Plan will require City Council approval, budget re-appropriation, and delay the progress of existing Work Plan items with the existing staffing.
