F3. Recommend a preferred alternative to the City Council for the Ravenswood Avenue Railroad Crossing Study (Staff Report# 17-008-CSC)

Staff Obeso and project consultant provided a presentation (Attachment).

Public Comments:

- Diane McGrath spoke on the need to improve the Encinal Avenue Caltrain crossing and provided recommendations.
- Steve Schmidt spoke in support of a viaduct through City boundaries.
- William Brown spoke in support of Alternative C but preferred viaduct if feasible, and then asked for clarification on pedestrian circulation around the station.
- Joseph P. Davis spoke about bicycle connectivity, and then asked for clarifications on parking impacts, station access, and Planning Commission's rationale for recommending Alternative A.

ACTION: Motion and second (Mazzara/Levin) to recommend Alternative C to the City Council, passes (6-3-0; Kirsch/Meyer/Weiner dissent).















Rail Profiles










Traffic Patterns/Circulation














