### A. Call to Order

Chair Walser called the meeting to order at 7:10 p.m.

### B. Roll Call

Staff Chen provided a summary of the City's biannual resident satisfaction survey and City Council actions on transportation related items since the January 10, 2018, Commission meeting.

## E. Regular Business

E1. Approve the Complete Streets Commission regular meeting minutes of January 10, 2018

E2. Provide feedback on conceptual Chilco Streetscape Improvements between Bayfront Expressway and Hamilton Avenue (Staff Report #18-002-CSC)

 Jen Wolosin spoke in support of a sidewalk on the west side of Chilco Street south of Constitution Drive.

By acclamation, the Commission recommended staff proceed with detailed engineering project design and requested to review the design set when available.

Staff Chen provided a presentation on major changes made to the 2017 Work Plan (Attachment).

Staff Chen provided an update on existing traffic conditions due to the turn restrictions.

F3. Presentation by the Middle Avenue Pedestrian and Bicycle Rail Crossing Subcommittee

Commissioner Weiner provided a presentation on the need to widen the existing sidewalk on the east side of El Camino Real from Cambridge Avenue to the southern City limit. (Attachment)

Staff Chen explained additional discussions with Caltrans and other City departments will be needed to assess the feasibility of this proposal.

F4. Update on major project status

Staff Chen provided project updates on the two ongoing projects in the Neighborhood Traffic Management Program, the Willow Road/U.S. 101 interchange construction, and Ravenswood Avenue railroad crossing.

to a Study Session given to the City Council on February 6, 2018, on potential alternatives to form a Transportation Management Association. Commissioner Levin also reported the next discussion on the Caltrain Go Pass program will be held at a Manager Mobility Partnership forum.

G3. Update from Oak Grove, University, Crane Bicycle Improvement Project Subcommittee

There was no Subcommittee report.

G4. Update from Safe Routes to School Program Subcommittee

Commissioner Mazzara reiterated the Subcommittee's desire to be involved in the consultant selection process.

G5. Update from Transportation Master Plan Subcommittee

Commissioner Levin reported that the Subcommittee met in early February and provided a summary of the Subcommittee's observations and feedback on the Transportation Master Plan goals and metrics based on Commissioner Levin's participation at the October 30, 2017, Oversight and Outreach Committee meeting and published meeting minutes.

• Jen Wolosin encouraged Commissioners and the public to be engaged in the master plan process.














# TRUCK ROUTE MAP







### Recommendation

Staff requests that the Complete Streets Commission provide feedback on the citywide bicycle wayfinding sign plan (Attachment A).

### **Policy Issues**

The proposed project is consistent with policies stated in the 2016 General Plan Circulation Element. These policies seek to maintain a safe, efficient, attractive, user-friendly circulation system that promotes a healthy, safe and active community and quality of life throughout Menlo Park.

## **Background**

On August 11, 2014, the former Bicycle Commission reviewed and approved a design template and installation of citywide bicycle wayfinding signs. In early 2016, with input from the Town of Atherton, the City installed several wayfinding signs at various locations as shown in Attachment A.

Currently, bicycle wayfinding signs can be found connecting the Menlo Park Caltrain Station and the Bay Trail via Oak Grove Avenue, Laurel Street, Ravenswood Avenue, Ringwood Avenue, Ivy Drive, and Willow Road. Each wayfinding sign includes one destination (i.e., "Caltrain Station" or "Bay Trail") and an arrow (i.e., left / through / right arrows). The wayfinding signs are generally located in advance of intersections where key directional turns are required to reach the destinations, and designed to display up to three destinations.

### **Analysis**

Since 2016, the City has improved existing and added multiple bicycle facilities throughout the city. Additionally, the following bicycle projects are expected to be constructed by Facebook as part of their Facebook Campus Expansion project in the near future:

- Improved buffered bike lanes on Chilco Street between Constitution Drive and Fire Station No. 77
- New bike lanes on Chilco Street between Fire Station No. 77 and Hamilton Avenue
- New bike routes (or "sharrows") on Hamilton Avenue between Market Place and Chilco Street
- New pedestrian/bicycle bridge crossing Bayfront Expressway approximately 0.25 miles east of Chilco Street

As the City and Bay Area region continue to experience residential and commercial development growth

and generate more recreational public facility uses, people that elect to bike to their desired destinations can benefit from more informative bicycle wayfinding signs. As a result, staff recommends the following changes to the bicycle wayfinding sign plan:

- For individual destination Add estimated distance (rounded to the nearest 0.1 miles) and arrival time based on an average bicycling speed of 10 miles per hour (mph).
- Number of destinations per wayfinding sign Maximize destinations on each sign as suggested below based on direction of travel and likelihood to be traveled by bicyclists:
  - Eastbound
    - Bay Trail (existing)
    - Bedwell Bayfront Park (new)
    - Onetta Harris Community Center (new)
  - Westbound
    - Caltrain Station (existing)
    - Downtown (new)
    - Nealon Park (new)
- Location of wayfinding signs Install new wayfinding signs on Hamilton Avenue, west of Chilco Street, to supplement the future bicycle facilities mentioned above.

All new wayfinding signs on Hamilton Avenue are expected to be constructed by Facebook as part of their Facebook Campus Expansion project.

While staff has chosen public facilities as they are more likely to benefit both residents and non-residents, individual destinations can continue to evolve as demand changes.

## **Impact on City Resources**

Project implementation, with the exception of Hamilton Avenue, will be funded through the City's Citywide Street Signing and Striping Program.

### **Environmental Review**

This Commission action is not subject to the current California Environmental Quality Act (CEQA) guidelines.

The project is categorically exempt under Class 1 of the CEQA guidelines. Class 1 allows for minor alterations of existing facilities, including highways and streets, sidewalks, gutters, bicycle and pedestrian access, and similar facilities, as long as there is negligible or no expansion of use.

### **Public Notice**

Public notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting.
