E2. Consider recommendation to City Council to make permanent the temporary turn restriction measures installed in the Willows neighborhood (Staff Report #20-003-CSC)

Staff Angulo and Patrick Golier from Parisi Transportation Consulting made the presentation (Attachment).

- Julie Forbes spoke against the project due to increased time to exit the neighborhood.
- Amar Murugan, Tricia Barr, Amy Roleder, Keith Roleder, Brian Gilmer, Tracy Morris, Michelle Heeseman, Chitra C., François Bailly, Michele Barry spoke in support of the project.
- Carol Hosinger and Kevin Hosinger stated the project increased time to exit the neighborhood and inquired about impact due to COVID and police enforcement.
- Llan Hornstein spoke in support of the project and suggested enforcement leniency for neighborhood residents.

**ACTION:** Motion and second (Meyer/Behroozi) to recommend to City Council to make permanent the temporary turn restriction measures installed in the Willows neighborhood, and to exempt bicycle from turn restrictions, passed (8-0-1, Cromie absent).

With consent from new Chair Levin, Commissioner Behroozi continued to facilitate meeting.

# Willows Neighborhood Turning Restrictions

## Background


- PM peak-hour congestion on Willow Road had encouraged cut-through traffic in the Willows neighborhood
- Construction on the Highway 101/Willow Road interchange increased cut-through traffic
- City of Menlo Park installed four PM peak-hour turning restrictions to reduce cut-through traffic
- Construction on the interchange is now complete
- Parisi Transportation Consulting hired to analyze traffic volume data and provide a recommendation on the permanency of the restrictions




## Timeline

- Spring 2017: "Before" traffic counts completed
- May 2017: Caltrans began construction of the U.S. 101/Willow Road interchange
- December 2017: PM peak-hour turning restrictions installed
- Spring 2019: "After" traffic counts completed
- January/February 2020: A public survey was completed to gauge public opinion on the turn restrictions


### **Turn Restrictions in the Willows Neighborhood**










### The Willows Neighborhood: Change in Daily Traffic Volumes (2017 – 2019)










### The Willows Neighborhood: PM Peak Hour Traffic Volumes (2017 & 2019)



## PM Peak Hour Turning Movements

- Right from Durham Street to Willow Road
  - ► 2017: **218** vehicles
  - ► 2019: **17** vehicles
- Right from Gilbert Street to Willow Road
  - ► 2017: **35** vehicles
  - ► 2019: **58** vehicles
- Right from Willow Road to Middlefield Road
  - ► 2017: **334** vehicles
  - ► 2019: **203** vehicles

## Traffic Count - Summary

- Total daily traffic in NB direction towards Willow Road decreased on Chester and Durham Streets though increased on O'Keefe Street
- Durham/Willow over 90% reduction in number of vehicles turning right in PM peak hour from Durham to Willow
- Gilbert Avenue corresponding increase of 23 vehicles
- Middlefield/Willow 40% reduction in numbers of vehicles turning right onto Middlefield in PM peak hour from Willow

## Public Survey

- January 17<sup>th</sup> to February 3<sup>rd</sup>, 2020
- Postcards advertising the online survey were mailed to residents in the neighborhood and posted to NextDoor, Twitter, and Facebook.
- 417 responses received






Prior to the installation of the turn restrictions, you thought cut-through traffic in the Willows neighborhood was:




## Public Survey(cont.)

Did you change your typical traveling patterns as a result of the turn restrictions?






## Public Survey (cont.)

## Public Survey – Comments Received

- The turn restrictions have improved quality of life for neighborhood residents
- Turn restrictions have increased travel times to and from Highway 101 for some respondents
- Turn restrictions are not adequately enforced by Menlo Park Police
- The intersection of Woodland Avenue and Blackburn Avenue has poor visibility
- Intersections on Willow Road frequently blocked
- Exemptions should be made for neighborhood residents and/or bicyclists

### Recommendation



- Overwhelming compliance with the restrictions
- Minimal impacts on other neighborhood streets
- Strong public support for keeping the turn restrictions in place permanently
- Recommendation to retain turn restrictions
