### Recommendation

Staff recommends that the Complete Streets Commission (Commission):

- Adopt a resolution (Attachment A) to install no parking zone (two on-street parallel parking spaces) on Valparaiso Avenue west of 1360 Crane Street.
- Provide direction on a streamlined process for future no parking zones requests at intersections and mid-block crosswalks, as illustrated in Attachments B and C from the California Manual on Uniform Traffic Control Devices (CA MUTCD).

These alterations are intended to enhance safety by improving driver line of sight.

### **Policy Issues**

These alterations are consistent with policies CIRC-1.1, CIR-4.4 in the 2016 General Plan Circulation Element. These policies seek to maintain and improve a circulation system through the Street Classification System that provides safe and efficient movement of people and goods throughout Menlo Park for residential and commercial purposes.

The CA MUTCD sets statewide standards for traffic control devices (e.g., signs, street markings, traffic signal, etc.), to promote roadway safety and efficiency.

### **Background**

In October 2022, staff received a resident request to address inadequate line of sight for the westbound direction on Valparaiso Avenue for residents exiting 1360 Crane Street. The residential unit is located on the southeast corner of Valparaiso Avenue and Crane Street, a T-intersection and the garage access is on Valparaiso Avenue.

According to the resident statement, parked vehicles between the residential driveway and Crane Street make it difficult to safely back out onto Valparaiso Avenue, especially during commute hours. Under existing conditions, drivers are forced to encroach into the existing bike lane before they can clearly see approaching vehicles.

Generally, Valparaiso Avenue has a posted speed limit of 30 miles per hour (mph), but this section is part of a 25 mph designated school zone. Crane Street has a prima facie speed limit of 25 mph.

According to the American Association of State Highway and Transportation Officials' (AASHTO) Policy on Geometric Design of Highway and Streets, a minimum of 155 feet of stopping sight distance is required for a 25 mph roadway, while 200 feet is required for a 30 mph roadway. Currently, there are six feet of red curbs on both sides of the driveway.

### **Analysis**

Based on field investigation, to get a clear view of approaching vehicles on westbound Valparaiso Avenue or right turning vehicles from northbound Crane Street, 1360 Crane Street residents backing out of their driveway have to cross beyond the edge of parked vehicles and into the existing bike lane before receiving a clear line of sight.

Per the request, to achieve the minimum stopping sight distance for the driveway for vehicles traveling on westbound Valparaiso Avenue, staff recommends extending the existing six feet no parking zone by eliminating the two parking spaces between the driveway and Crane Street, totaling 31 feet. The elimination of these spaces is consistent with the CA MUTCD recommendation of establishing a minimum no parking zone of 20 feet at an intersection (Attachment B).

### Future no parking zone requests

Currently, the Commission has authority (Muni Code Section 11.24.026) to designate no parking zones adjacent to driveways, intersections and crosswalks for up to three spaces within the "Downtown/Station Area" and up to five spaces outside of that area. The "Downtown/Station Area" is approximately bounded by Menlo Avenue, Oak Grove Avenue, University Drive and Alma Street.

As traffic continues to increase toward pre-pandemic level, staff anticipates future requests to continue to grow. While driveway requests are generally unique to their specific surroundings, intersection and midblock crosswalk requests are more standard and can be referenced through the CA MUTCD. As a result, staff believes future intersection and mid-block crosswalk no parking zone requests could be further streamlined by:

- Granting City staff citywide authority to designate no parking zones at intersections and mid-block crosswalks consistent with CA MUTCD guidance (Attachments B and C)
- Continuing the current process if additional space removals are needed near driveways or beyond the CA MUTCD standard

#### Next steps

Per Municipal Code Section 11.24.028, if the new Valparaiso Avenue no parking zone is approved, any Menlo Park resident, business owner, or property owner may appeal to the City Council in writing within fifteen (15) days after the decision, by February 23, 2023.

For future intersection and mid-block requests, if the Commission is supportive of staff's recommendation, the Commission can recommend to the City Council to adopt the proposed process outlined above.

### Impact on City Resources

If approved, this low cost alteration will be implemented either through the City's signing and striping maintenance program or the City's Maintenance Division.

#### **Environmental Review**

The installation of red curb is categorically exempt under Class 1 (Section 15301(c)) of the California Environmental Quality Act. Class 1 allows for minor alterations of existing facilities, including highways and streets, sidewalks, gutters, bicycle and pedestrian access, and similar facilities, as long as there is negligible or no expansion of use.

#### **Public Notice**

Public Notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting. Additional public outreach was achieved by sending notification postcards to residents/property owners within 500 feet of the proposed "No Parking Zone". In addition, posters with the alteration and meeting information were placed on A-frames at the site.

NOW, THEREFORE, BE IT RESOLVED, that the Complete Streets Commission of the City of Menlo Park does hereby authorize the installation of a no parking zone, west of 1360 Crane Street, as shown in Exhibit A.





Existing condition at 1360 Crane Street (Valparaiso facing)




Proposed conditions
