# Re: Discussion of Climate Action Plan goals and Greenhouse Gas (GHG) reduction strategy

In the past, the Environmental Quality Commission has held preliminary discussions of the following:

- Drafting a Climate Action Plan ("CAP") Update to replace the October 2015 Update specifically, updating the "Five Year Community GHG Reduction Strategies" ("Reduction Strategies") through 2020. The original October 2015 CAP Reduction Strategies are listed below.
- 2. Determining criteria for determining which activities/projects to include in the Reduction Strategies, and how to prioritize them.
- 3. Determining criteria for, and ultimately applying those criteria to recommend, a post-2020 CAP goal.

Tonight's meeting includes a block of time to have this discussion. Ideally, the result of the discussion would be:

- 1. A list of criteria for selecting GHG reduction strategies. (See below for sample criteria)
- 2. An initial list of GHG Reduction Strategies to consider in the period between now and December 31, 2020, whether prioritized or not. (See below for sample Reduction Strategies)
- 3. A list of criteria for a post-2020 CAP goal.

### Points to note:

- 1. In November 2017, the CAP Subcommittee created a list of CAP priorities for the period through early/mid 2018, when staff was otherwise occupied with hiring and other urgent matters. That list is included below to the extent it may be useful in this discussion.
- 2. In making its list, the CAP Subcommittee reviewed a list of GHG reduction practices and criteria, which is also included below and may help inform the discussion.
- 3. The results of this discussion and lists may be helpful in drafting the Environmental Quality Commissions' 2-year work plan for 2019-2020 later this year.
- 4. The city's GHG inventory is outdated. One of staff's activities this year is to update it.

# Sample Criteria:

- 1. GHG emissions reduced
- 2. Extent to which any expenses can be covered with CAP funds
- 3. Extent of staff resources to implement
- 4. Number of residents who benefit directly
- 5. Environmental justice interests served
- 6. Extent to which strategy is scalable, replicable
- 7. Extent to which resident education/training is needed

# Sample Reduction Strategies:

- 1. Extend M2 Green/Sustainable Building Code to 1) Downtown Specific Plan, or 2) entire city
- 2. Strengthen EV charging infrastructure building code requirements
- 3. Streamline EVCI permitting process (including by pre-approving certain electricians)
- 4. Waive fees for EVCI permitting
- 5. Update and implement city's Sustainable Purchasing program, including EV First policy
- 6. Commission a study on financial strategy for adding EVCI to existing buildings, especially multi-unit dwellings
- 7. Install public EV superfast charger
- 8. Install public EV level 2 charger
- 9. Install public EV charger(s) in disadvantaged communities
- 10. Pilot EV car sharing program like the one in Los Angeles
- 11. Implement renewable water heating building code
- 12. Pilot resident education program on reducing GHGs
- 13. Pilot EV community class; advertise via Menlo Park Activity Guide (Parks and Rec)

# EQC CAP Subcommittee Proposal: Priorities for upcoming months

Priorities:

- Achieve max GHG reductions at lowest cost (See chart below from Menlo Spark)
- Avoid adding burden on staff
- Advise City Council via letter re EQC position on EV Charging Infrastructure building code requirements (cc Deanna Chow, Rebecca, head of Planning Commission) to be approved by EQC at 11/15 meeting (see draft letter below)
- 2. Alert Facebook of EVCI recommendations, seek FB input, and invite FB to also give recommendation to City Council.
- 3. Contact Chamber of Commerce (11/30 meeting of Business Issues and Transportation Subcommittee), multi-unit property managers with proposed building code requirements and seek their input/support.
- 4. Propose that City pursue streamlined, reduced-price permitting for EVCI, to benefit residents and ease burden on staff
  - a. Ask if City can pre-approve certain electricians and installers, to avoid need for city inspection
  - b. Advocate for free permits for EVCI (like MP has done with solar permits)
- 5. Recommend to City Council to adopt an "EV First" policy for the city fleet
  - a. Recommend an EV First policy based on existing model ordinances
  - b. EQC to suggest to San Mateo County and Peninsula Clean Energy to pilot bulk purchases of electric fleet vehicles for city fleets; if this happens, encourage City to participate.

# Ongoing:

1. Advise City to expand M2/Bayfront Green and Sustainable Building Code to entire city as soon as possible.

# Future actions:

- 1. Draft communication around EVs for city to share with residents, via website, FB, other social media, email, letter, advising them of actions they can take to reduce GHG emissions in Menlo Park.
- 2. Ask City to adopt renewable water heating ordinance (like the one we recommended the City support to the CEC)

Fiscal Year 2015-16

□ Complete installation of Solar PV on four City buildings

□ Complete installation of four Electric Vehicle (EV) Charging stations at City public parking locations

□ Incorporate CAP strategies and GHG emission reductions into General Plan update

Complete energy efficient upgrades and renewable energy installation at city facilities

□ Consider Community Choice Energy (CCE) options to gain additional renewable power in Menlo Park's portfolio

□ Complete evaluation of methane capture and treatment at Bedwell Bayfront Park (Closed Landfill)

Fiscal Year 2016-17

□ Incorporate Zero Net Energy and LEED Silver requirements into Planning requirements and Building Codes to increase efficiency in new buildings

□ Implement Energy Star ratings requirement, or other performance tracking methodology, into Planning requirements for new buildings

□ Consider changes to City's solid waste, recycling, and organics collection franchise that encourage zero waste and decrease waste to landfill

□ Consider developing an energy efficient/renewable energy plan for commercial and residential sector to reinvigorate energy upgrades for existing buildings

□ Re-invigorate a social marketing program to increase biking, public transit, and walking in the community

□ Implement CCE, if selected as an option

Fiscal Year 2017-18

□ Support Transportation Commission's car sharing program

□ Support Bicycle Commission's bike sharing program

□ Consider program to increase Caltrain ridership by downtown employees

□ Encourage local food production through social marketing, education, and community garden programs

□ Consider large scale renewable energy generation within Menlo Park (such as solar farm on a portion of open space, or large number of solar roof-top installations)

Fiscal Year 2018-19

□ Revisit City Environmental Purchasing Program (EPP) to consider requiring new City buildings, facilities, and vehicles meet certain minimum environmental attributes

□ Revise 2004 City Street Tree Master Plan, with the support of the City Arborist, to increase urban tree canopy

□ Consider fuel switching strategies to move residential and commercial energy from natural gas and other fuels to renewable electricity portfolio

□ Consider consumption based community engagement program to reduce GHG impacts of plug load, food and consumer goods purchased in Menlo Park

Fiscal Year 2019-20

Consider replacement of all remaining City non-LED street lights with LED fixtures

Consider height and density limit adjustments to promote active and public transportation

□ Consider resiliency strategies for protecting Menlo Park land in the projected Sea Level Rise (SLR) zone

□ Robust Climate Action Plan update community engagement program to craft Menlo Park's strategy looking forward to 2040

For All Years 2015-2020:

□ Continue implementation of City EPP, residential and commercial water, waste and energy efficiency programs

The above is a recommended timeline only. New policies and programs related to GHG reductions may require a comprehensive cost-benefit analysis. Nearly all policies and programs would require City Council approval prior to implementation. In addition, the five-year strategy also reflects what can be accomplished with current staff resources.

Sustainability Manager Rebecca Lucky provided an update on staff recruitments, City Council's approval of garbage rate increases and development of a Sustainability Division work plan.





**ACTION:** Motion and second (Martin/Dickerson) to support the proposed 2018 activities for the Sustainability Office presented in the staff report (numbered one through nine). In particular, the Environmental Quality Commission strongly supports the update to the Heritage Tree Ordinance Update as a high priority to complete by the end of this year.

The Environment Quality Commission also advises the City Council to use the Climate Action Plan funds identified in the Capital Improvement Plan to expedite (if additional funding is needed) the following activities:

- An update to the community greenhouse gas inventory;
- Development of a Transportation Master Plan;
- Extending the new electric vehicle charging station requirements citywide; and/or
- Supporting the implementation of new green design standards in the General Plan

If no further funding or resources are needed to expedite the climate action plan related items proposed in the staff report, the Environmental Quality Commission advises the City Council to use the Climate Action Plan funds in the Capital Improvement Plan to:

Undertake a Phase II of the electric vehicle charging station policy by completing a gap analysis
of areas in the community that are undersupplied with electric vehicle charging stations (such as
residential or existing commercial areas) and identify policy and/or program options to prepare
the community for a full transition to electric vehicles and encourage a higher rate of electric
vehicle ownership; and/or

2. Undertake a Phase II of the new green design standards in the General Plan that could include extending the requirements to other areas of the city.

The Environmental Quality Commission designates the Chair to communicate this action to the City Council. (4-0-3; Bedwell, London, and Smolke absent)

D2. Discuss the Environmental Quality Commission's quarterly report to the City Council
