Discuss revenues and expenditures for fiscal year 2008-09.

- Committee discussed revenue and expenditures actuals. Three revenue accounts were highlighted for discussion since they did not meet budget expectations of three percent (3%) and greater: Transient Occupancy Tax, Licenses and Permits and Sales Tax; typically, these accounts are affected by the economy as it fluctuates up and down.
- Committee discussed expenditures and how encumbrances affect the budget. Carol answered questions regarding how encumbrances are accounted for at year-end.
- Committee suggested including in the next meeting a discussion of key messages for reporting the Quarterly Financial Review of the General Fund Operations as of September 30, 2009.
