

# HOUSING COMMISSION MEETING MINUTES

Chair Boyle called the meeting to order at 5:30 p.m. in the Administrative Building Conference Room.

#### **B. REGULAR BUSINESS**

1. Continuation of Process for Commission 2-Year Workplan

City Clerk Margaret Roberts joined the Commission for the discussion. Housing Commissioners shared their experiences talking to five other residents about the Housing Commission.

Following this, commissioners discussed the Commission's current mission statement and how it could change. It was agreed the mission statement should be simple and broadly worded. City Clerk Roberts said as long as the mission statement doesn't go against established policy, the Commission's revised mission statement does not have to be approved by the City Council.

The Commission agreed on the following draft mission statement but did not vote on it: "The mission of the Housing Commission is to make recommendations to the City Council on issues related to housing policy, implement Council policy decisions, and represent the City where needed on housing matters."

City Clerk Roberts will prepare notes of the discussion and email them to the commissioners. She will also prepare a staff report related to this and include it in commissioners' August meeting agenda packets. She will attend the August Housing Commission meeting.

Housing Manager Frederick reported on the status of the BMR acquisition and rehabilitation project (a single-family home) on Hollyburne Ave.

Chair Boyle reported that the Clara Mateo shelter, currently located on the grounds of the Menlo Park V.A., will be closing its doors in December. They are forced to close because the V.A. needs the space they presently occupy. Clara Mateo has been unsuccessful so far in locating an alternate location for the shelter. She also provided a status report on the City's downtown/El Camino Real development plan.
