LIBRARY COMMISSION MINUTES

The meeting was called to order by Chair Cebrian at 6:35 p.m.

Approved a subcommittee of Bramlett, Cebrian and Sloo to design the questionnaire and bring it back in draft form for the full commission to review at their next meeting.
