A. Call to Order

Chair Cebrian called the meeting to order at 6:44 p.m.

D. Regular Business

D1. Identify topic list for Library focus group discussions

Commissioner shared the topics brought up by the library survey respondents that they would like to explore with focus groups. They included services, space, hours, the location and collection at the Belle Haven branch, services for seniors, services in Sharon Heights, mobile and remote services, training for e-services, and outreach to groups not currently being served. Commissioner Nelson summarized this discussion as one focusing on "services and spaces".

ACTION: Motion and second (Lemons/Leep) to form a subcommittee of Commissioners Nelson and Leep to create a rough draft of focus group questions and to make decisions on focus group composition and methodology. Motion passed 6-0-1 with Commissioner Manuel absent.

D2. Subcommittee report on Library Commission presentation to City Council

Commissioners Bramlett and Lemons reported back on their September 29th presentation before the City Council. Commissioner Bramlett noted that their presentation received a public comment at the meeting urging more programs at the Belle Haven branch. Commissioner Lemons discussed shaping the report differently next time to streamline it. Both Commissioners reported that the report was well received by the Council, and that Councilmembers made positive and supportive statements about the Library.

Nick Szegda reported on the recent bedbug discovery at the main library. The library has been cleaned and cleared. A follow-up check for bedbugs will take place on October 26, and a staff seminar on bedbug identification will take place on October 28. The Belle Haven branch was checked and found to be bedbug free. Science Night will be on November 5th from 6:30 to 8:30 PM.
