A. Call to Order

Chair Bramlett called the meeting to order at 6:35 p.m.

B. Roll Call

C. Public Comment

Ester Bugna from the Menlo Park Historical Association spoke about wanting to strengthen ties between the Commission and the MPHA.

D. Presentations and Proclamations

D1. Presentation thanking outgoing Commission Chair Cebrian for her service to the Commission

Chair Bramlett expressed appreciation on behalf of the Commission and Staff for Commissioner Cebrian's hard work as past Chair of the Library Commission.

E. Regular Business

E1. Discuss Commission 2016-2017 goals and April Commission update to City Council.

General discussion about developing new Commission goals starting from Commission's most recent work plan. Cebrian – Small Business collection is now a "heritage" collection – should this remain a Commission focus? Bramlett – would like to see an organized effort to network with key leaders and connect more with community groups. Library item 53 on the City Council's work plan – does the Council have particular community stakeholders in mind? New priorities – library programming, folding e-services into programming, taking library services out into the community. Supporting outcomes of strategic planning process and space needs study.

ACTION: Motion and second (Leep/Lemons) to have Chair Bramlett to develop new goals for the Commission based on above discussion and present them at the next Commission meeting, passed 4-0.

April 26th presentation to City Council discussion. Bramlett – focus on library services in Belle Haven. Updates on Strategic Planning and upcoming Space Needs study. Update Council on new Commission goals and work plan.

ACTION: Motion and second (Cebrian/Leep) to form subcommittee of Bramlett and Lemons to draft presentation to Council passed 4-0.

E2. Discuss recruitment of new Commission members

Individual Commissioners have made outreach efforts to neighbors and acquaintances. The application form is up on the City's web site and paper flyers encouraging applications are in the library.

ACTION: Bramlett posted City recruitment message to Next Door site, other Commissioners to look for opportunities to encourage Commission applications from community members.

Szegda reported that budget priorities might shift depending upon the outcome of the strategic planning process. There has been an emphasis on library programming and library events. Funding levels will remain the same.

Bramlett and Leep attended recent Connect Menlo Meeting. Commissioner Lemons will be visiting the Boston Public Library next month and will report back. Commissioner Leep visited the Redwood Shores library.
