D1. Accept the commission meeting minutes from April 17, 2017

D2. Welcome new Commissioner Ester Bugna

The Commission welcomed new Commissioner Ester Bugna, long time Menlo Park resident, recently appointed.

D3. Report from Belle Haven Subcommittee

Commissioner Bramlett shared the results of the survey gathered at the recent Belle Haven Community Fair. The 36 survey respondents showed an interest in programs at the library and in free book giveaways. Chair Lemons reported that resident Matt Henry gave a presentation at a recent neighborhood meeting advocating for a new library located on the Onetta Harris Senior Center campus. Input from attendees at that meeting did not favor placing a new library on Willow Road.

D4. Report on Little Free Libraries

Cebrian distributed a document with links to successful, public parks located Little Free Library programs in cities that are similar in size to Menlo Park. MSP (Bramlett/Lemons – passed unanimously) for Cebrian and Badgely to draft a letter to Council proposing a pilot program to place Little Free Libraries in three City parks: Kelly, Marketplace, and Sharon.

Background

Library Budget update for FY 2017/18

The City Council will vote on June 20 to approve the budget for the 2017/18 fiscal year. The library's asks include expanding hours for the branch library (to match the main library's hours, when possible, outside of school hours). The 13 additional hours would mean the branch would be open until 9 Monday through Wednesday, 10-5 on Saturday, and would open 12-5 on Sunday. The library has requested an additional .5 FTE to help staff the expanded hours. Also included in the library's budget requests are funds for a Belle Haven neighborhood library needs assessment, and funds to prepare drawings to advance the space needs study for the main branch.

Design Thinking Workshop

Four library staff members attended a daylong training at the San Jose Public Library on using design thinking on June 7. Design thinking takes some of the tools and methods that designers use in their work, and applies them to solve other problems. It is end user focused (something that libraries often struggle with). The method staff used at the workshop involved coming up with real issues that are affecting our library users and designing prototypes that solved the problems. The workshop was presented by staff from the Chicago Public Library and staff from IDEO. Their ideas can be explored at www.designthinkingforlibraries.com.

Programming and events
