### E. Informational Items

E1. Presentation from Jason Sugimura on adult literacy program Project READ

Jason Sugimura, Interim Project READ Director, gave an overview of Project READ's adult literacy programs. There is a new Outreach Specialist, Justin Pham, working for Project READ. A volunteer appreciation event will be held October 28. There is currently a 3 month wait for learners who want one-on-one tutoring.

E2. Presentation from Steve Haas – Friends of the Library

Steve Haas, President of the Friends of the Library, and Wayne Bonde, immediate past President, gave a report. There are 50 volunteers who work 8,000 volunteer hours a year raising money through in-library and online book sales. They are always looking for volunteers.

E3. Presentation from Jacqui Cebrian – BHNLAC

Jacqui Cebrian, Chair of the Belle Haven Neighborhood Library Advisory Committee, shares the Committee's draft response to the Gensler needs assessment report. The Committee is recommending a new, separate, branch facility, and is discussing the composition and role of the Committee moving forward now that the needs assessment is coming to an end.

E4. Presentation from Monica Corman - Library Foundation

Monica Corman spoke of the Foundation's role as a fundraising group for major capital projects for the library. She and Foundation member Elyse Stein shared a video the Foundation made that

explained the role of 21<sup>st</sup> century libraries. The Foundation expressed their desire to move ahed despite the Council pause on the main library portion of the Library System Improvements project.

E5. Menlo Park Historical Association presentation

Bo Crane and Pamela Jones from the Menlo Park Historical Association shared their mission of collecting, preserving, and disseminating historical information about Menlo Park. MPHA publishes works that focus on local history, maintains a historical archive in the library basement, and organizes tours, events and lectures that are open to the public.

E6. Project READ Literacy Partners presentation

E7. Library System Improvements project update

The Council has decided to place a pause on the main library portion of the project and take it up again when the new Council reconvenes in January 2019. The Council will be moving forward with the Belle Haven portion of the project, and there will be a staff presentation of the needs assessment results at an October Council meeting.

E8. Report from the Assistant Director

Assistant Director Szegda reported that the selection of three new librarian positions was nearing completion. The new staff members were expected to begin work later in the fall. Library Director Susan Holmer announced her retirement, effective in early October.
