H. INFORMATION ITEMS:

1. Measure T Projects Update

Curtis Brown, Community Services Director, told the Commissioners about the Ivy Drive Plaza Dedication which was held on March 16th at 1:00 p.m. The Children from Belle Haven Child Development Center and Belle Haven School held hands from the entrance of the school to the entrance of the Development Center.

The Tom Harrison Field Dedication is scheduled for April 9th. A big opening dedication is being planned for July 4th.

2. Off-leash Dog Areas Update

Curtis Brown, Community Services Director gave an update on the Off-leash Dog Areas. The off-leash areas at Willow Oaks Park and Nealon Park officially opened on Monday, March 21, 2005. A letter was sent out to the community with the off-leash area rules.

3. Director's Update

Curtis Brown, Community Services Director, gave a recap of what was already discussed. A bid was chosen for the old Menlo Park Police Department and construction will begin as planned. The Grand Opening Celebration for Burgess Park has been scheduled for July 4, 2005.

4. City Council Priority Setting Projects for Community Services Department

Curtis Brown, Community Services Director, gave the Commission the City Council's 2005-06 Project Priorities Forms for the Community Services Department. The projects include Public Art Programs, Cost Recovery Policy and Fee Subsidy Programs.

5. Community Services Department Fees 2005-2006

Curtis Brown, Community Services Director, gave the Commission the Master Fee Revisions and/or Additional Fee Recommendations for 2005. Dog license fees is a new fee of \$30 per dog and \$20 each additional dog. Non-resident fees will be double the resident fees. Onetta Harris Facility Rentals is a new fee for the use of the Art room. There is a 6 percent increase for Gymnastics. The Child Care rates will be increased by 5 percent at Menlo Children's Center. The Concession Stand is a new fee. Each group will be required to pay a \$250 deposit fee. Fees are \$75 per day and \$250 for three specific 3-month periods.

6. Debriefing of Commission Training Workshop

A training of the Brown Act has been scheduled for all the Commissioners on April 22, 2005.
