3. Nealon Dog Park – Schel Reyes

Schel Reyes, DOGMA, addressed the Commissioners regarding the Dog Park at Nealon Park. She mentioned that DOGMA is requesting the City put a double gate at the dugout at Nealon Park for the safety of the dogs and a double gate in the outfield for the safety of the senior citizens arriving at Little House. DOGMA is also concerned with the drainage problem at Willow Oaks Park and is willing to work with the City and the Commission to find a solution. She also mentioned that DOGMA would like to request that the Dog Park hours be extended for Nealon Park from 7:00 a.m. to 11:00 a.m. and evening and weekend hours

be added. DOGMA would like the Dog Park hours for Willow Oaks Park to be extended from dawn to dusk. She mentioned financial resources and personnel are available to help the Commission with these projects. Following discussion, Barbara Santos George, Community Services Director, mentioned she would have an update for the next Commission Meeting on the status of the Dog Parks.

1. Measure T Community Meeting

Mike Taylor, Senior Recreation Supervisor, gave a brief presentation on phase one of the Measure T bond. Art Morimoto, Engineering Services Manager, gave a brief presentation on the preliminary recommendations for the next phase of bonds.

Public Comments:

Leslie Wombach – Portola Valley, mentioned she feels Measure T should be used on playing fields.

Ann Stoner – Menlo Park, mentioned she feels Measure T should be used on playing fields.

Cedy Fisher – Menlo Park mentioned she feels Measure T should be used on the gymnasium. The gym gets very hot during the summer, enrollment drops and it is miserable for the employees.

Bill Weseloh – Menlo Park mentioned it would be a great idea for the City to lease property in Stanford. He mentioned there is a lot of land in Stanford and they are willing to lease.

Nancy Borgenson – Menlo Park mentioned Measure T should be used to make Burgess Park a full size playing field. Art Morimoto, Engineering Services Manager, mentioned Staff will be writing a project priority for the Council to consider looking into reconfiguring Burgess Park and Kelly Park.

Commissioner Comments:

Commissioner Silano mentioned he would like the City Attorney to look into the Stanford lease option. Following discussion, the public was able to place six dots on what they feel Measure T should be used on.
