

#### COVID-19 SAFETY PROTOCOLS FOR USE OF OUTDOOR FACILITIES Department of Library and Community Services

- menlopark.org COVID-19 safety protocols for use of City of Menlo Park outdoor facilities
- I, the undersigned acknowledge that the following health and safety precautions are designed to prevent the spread of COVID-19 and are REQUIRED for all organized classes and activities in City of Menlo Park outdoor facilities:
- 1.Activities must take place 100% outdoors
- 2.All participants must maintain social distance 6' or more at all times
- 3.Social distance must be clearly marked on the field or hardscape so that outside observers can see it(paint/chalk on field, flags, cones, or similar demarcations)
- 4.No more than 12 participants at a time
- 5.Each participant must have all their own equipment and must not share any equipment with any otherperson at any time
- 6.Sports activities are limited to training exercises only no practice play or competitive team play
- 7. Face coverings must be worn by instructors at all times
- 8.Face coverings must be worn by participants at all times, with exception allowed only when participants are actively engaged in exercise. Social distance of 6' or more must be maintained at all times.

I, the undersigned agree that the organization listed below, including all its participants, staff, volunteers, players, parents, and spectators will fully comply in good faith with all state, county, and municipal public health requirements and guidelines when using City of Menlo Park facilities, including but not limited to the above COVID-19 safety protocols. I, the undersigned agree that failure to comply with the terms herein will result in the immediate revocation of my organization's facility use permit and the forfeiture of any and all permit and/or rental fees, and will further result in my organization and me personally being ineligible to use City of Menlo Park facilities for a period of no less than twenty-four (24) months after the date of the revocation. I, the undersigned agree to the terms herein and understand that my signature is a legal and binding signature and will be considered original if received electronically.
