#### Recommendation

That the Parks and Recreation Commission elect a Chair for the remainder of the 2021-2022 fiscal year.

#### **Policy Issues**

City Council Policy CC-01-004 was adopted in 1991 and outlines the procedures, roles and responsibilities of the City Council-appointed advisory bodies for optimal functioning. Amendments were made to the policy in 2001, 2011, 2013, 2017, 2019, and 2020.

#### **Background**

City Council Policy CC-01-004<sup>1</sup> requires commissions to elect a Chair and Vice Chair and to rotate those positions annually. The policy states that "The Chair and Vice Chair shall be selected in May of each year by a majority of the members and shall serve for one year or until their successors are selected." Because of a resignation, the election of a new Chair is taking place at the September 2021 meeting.

#### **Analysis**

The Parks and Recreation Commission Chair works with staff to set the agenda for the Commission's meetings, and presides over those meetings. The Chair has often delivered the Commission's annual update to the City Council. The Vice Chair serves as Chair in the Chair's absence. The Chair and Vice Chair are sometimes called upon to represent the Commission at ceremonial events.

Staff recommend that the Commission open the floor to nominations for Chair. Staff will tally nominations and votes.

#### **Next Steps**

The newly elected Commission Chair will begin their duties at the September 2021 Parks and Recreation Commission meeting and will serve until May of 2022.

#### Recommendation

That the Commission identifies a subcommittee to develop updates to the Commission's work plan.

#### **Policy Issues**

City Council Policy CC-19-004 was adopted in 2019 to establish the procedures, roles and responsibilities of Council-appointed advisory bodies. The policy requires that each Commission submit an annual work plan to the City Council for approval, and that the work plan be recommended by a majority of the Commission's members.

#### **Background**

Commissions are responsible for establishing an annual work plan that is in line with the City Council's goals, which guides the commissions' activities and projects. Once finalized by the advisory body, it is formally presented to Council for direction and approval and then reported out on by the advisory body during the year and at the completion of the work plan. Advisory body's work plans serve as a useful tool for both the advisory body and the Council to ensure that the work plan reflects the vision, mission, or priorities of the Council.

The Parks and Recreation Commission is charged with advising the City Council on matters related to City programs and facilities dedicated to recreation. This general charge includes advising on:

- Adequacy and maintenance of such facilities as parks and playgrounds, recreation buildings, facilities, and equipment.
- Adequacy, operation, and staffing of recreation programs.
- Modification of existing programs and facilities to meet developing community needs.
- Long range planning and regional coordination concerning park and recreational facilities.

The Parks and Recreation Commission adopted its current two-year work plan on June 27, 2018 (Attachment A) and met to review progress toward work plan goals on March 4, 2020 (Attachment B).

#### **Analysis**

The City Council approved the Parks and Recreation Commission's work plan at their August 6, 2018 meeting:

"For the years 2018-2020, the Parks and Recreation Commission will evaluate, advise and make recommendations in order to:

1. Provide high quality and inclusive programs and services that meet the diverse and changing needs of

all Menlo Park residents and neighboring communities;

- Ensure City Parks and Community Facilities are well-maintained, upgraded and/or expanded to improve accessibility and usage by a diverse population, while promoting sustainable environmental design and practices;
- 3. Improve class and program offerings, venues, partnerships and sponsorships to increase the quality and accessibility of educational, recreational, sporting, artistic, and cultural programs in the City of Menlo Park;
- 4. Support initiatives, partnerships and projects that intersect with the City's Park and Community Services resulting in well-coordinated efforts to meet the needs of residents."

The Commission met on March 4, 2020, to report out on the progress made toward their work plan goals and to create a new work plan. The COVID-19 pandemic and the subsequent disruptions to advisory body meetings have led to a delay in developing and approving a new plan.

Staff recommends that the Commission develop a new work plan through discussion or subcommittee work that aligns to the greatest extent possible with the City Council's priorities (Attachment C), the department's strategic plan (Attachment D), and the Parks and Recreation Facilities Master Plan (Attachment E).

#### Recommendation

That the Commission review updates to the Recreation Facility Use Guidelines.

#### **Policy Issues**

As a duly appointed advisory body to the City Council, the Parks and Recreation Commission may review and recommend updates to user policies and guidelines as the need arises.

#### **Background**

The Recreation Facility Use Guidelines (Guidelines), also known as the behavior policy, governs the public's use of recreation facilities.

Important considerations associated with the Guidelines include:

- Assuring equitable access to recreation facilities and resources for all community members;
- Maintaining a safe, clean and welcoming environment for all facility visitors;
- Facilitating the smooth and effective functioning of recreation facility operations; and,
- Ensuring a healthy, safe and productive workplace environment for Library and Community Services team members and volunteers.

#### **Analysis**

The Recreation Facility Use Guidelines are intended to ensure a public environment that is safe, welcoming, and inclusive for all community members by establishing clear expectations and rules for the shared use of recreation facilities. It is appropriate and necessary to conduct regular reviews of the guidelines and to update them as the need arises and in response to changing community needs and expectations over time. Staff recently updated the Guidelines to respond to issues that have arisen during the COVID pandemic. (Attachment A.)

#### RECREATION FACILITY USE GUIDELINES

Library and Community Services Department Updated September 22, 2021



#### **Purpose**

The City of Menlo Park strives to provide a safe, welcoming, pleasant and comfortable environment for all visitors of City facilities. To that goal, all facility visitors are expected to adhere to these Facility Use Guidelines.

We welcome everyone to:

- · Learn, discover, play, and enjoy City of Menlo Park facilities within the limits of their intended use
- Find facilities, equipment, and materials in good condition
- Feel safe and welcome
- Respect the rights of others to feel safe and welcome.

Visiting a City of Menlo Park recreation facility, including the premises and grounds outside a recreation facility, constitutes an implicit acceptance of these Guidelines and an acknowledgement of the right of City of Menlo Park staff to implement and enforce these Guidelines.

In case of an emergency, follow staff instructions promptly.

#### Prohibited conduct and activities

In consideration of all visitors and staff, the following activities are not allowed in City of Menlo Park recreation facilities, including the premises and grounds outside the facilities:

- Leaving a vulnerable adult or a child under the age of 11 unattended.
- Entering vacant classrooms or facility rooms unless approved by staff.
- Disturbing others by talking loudly or with other noisy activity—including any loud sound originating from any electronic device. Please do use headphones when listening to audio on any electronic devices.
- Conversing using a cell phone except in designated areas.
- Sleeping—as a safety precaution sleeping individuals will be awakened.
- Eating—except in the designated areas, or food provided at city-approved events.
- Drinking—except for covered beverages in the designated areas, or beverages provided at Library and Community Services-sponsored events.
- Presenting offensive and pervasive odor or odors that may make the use of the facility difficult for others.
- Bathing, shaving, haircutting, or washing clothes in the public restrooms.
- Leaving or storing personal belongings in program rooms, public spaces, or on the premises or grounds outside of facilities.
- Entering a facility without shoes or adequate clothing, including top and bottom.
- Bringing in animals other than service animals recognized under Titles II and III of the Americans with Disabilities Act (ADA).
- Leaving pets unattended and/or unleashed in outdoor areas near the facility, including but not limited to entryways, pathways, lawns, and outdoor seating areas.
- Bringing carts, bicycles, scooters, skateboards or similar items into any facility or leaving them at the entrance--except equipment that is designed and is being used for the purpose of assisting the mobility of persons with disabilities and/or equipment designed and being used to carry infants and children.
- Wearing skates or roller blades inside the facility.
- Changing a child's diaper—except in the designated area of the public restrooms.
- Blocking aisles, shelves or any thoroughfare with personal items, or leaving items unattended at any time--except to use the restroom for a reasonable amount of time.

#### **RECREATION FACILITY USE GUIDELINES**

Updated September 22, 2021

- Putting feet on facility furniture, rearranging the furniture or using the furniture for other than its intended purpose.
- For programs that require parents to sign in and out their children, ONLY the parents or guardians (over 18 years old) designated on the program sign up form will be allowed to pick up and/or drop off the child unless otherwise communicated with staff. ID will be required.
- Only participants who are registered for the class or program may be in attendance
- Siblings of a participant may not join the class or program without registering
- Parents are allowed in classroom or program space only if approved by instructor or city staff.
   Otherwise, parents must wait in designated areas
- Bringing weapons of any kind into the facility.
- Harassing facility users or staff—including physical, sexual, verbal harassment or stalking.
- Selling, soliciting or using illegal drugs on facility premises.
- Alcohol is prohibited, except at City-approved events.
- Soliciting money, donations or signatures, or the distribution or posting of any printed material without advance written approval of the City.
- Smoking, including using electronic and smoke-free cigarettes (vaping) inside or within 50 feet of the facility building.
- Vandalizing facility facilities, equipment or materials.
- Removing facility materials from the building without permission from authorized City staff.
- Engaging in sexual conduct or lewd behavior.
- Viewing or displaying inappropriate, sexually explicit, or illegal material in the facility.
- Violation of any federal, state, or local public health orders, restrictions, protocols and/or guidelines
- Illegal activity of any kind will be reported to law enforcement.

#### **Enforcement**

Failure to follow these Guidelines will result in the following actions:

- Individuals will be asked to leave the premises
- Facility visiting privileges may be suspended for an extended time period
- Facility staff may call local law enforcement to provide assistance in enforcing these Guidelines.
- Illegal activity in any facility may result in arrest and/or prosecution in addition to suspension of facility privileges.
- Customers who return to any City of Menlo Park facility before a suspension has ended may be charged with trespassing.

#### Additional information

- In case of an emergency, promptly follow all staff instructions.
- Theft or vandalism to City of Menlo Park property, or property of staff, or property of facility visitors is prohibited.
- State law permits staff to search purses, bags, parcels, briefcases, and other packages to prevent the theft of recreation equipment and materials, and authorizes the detention for a reasonable period of any person using these facilities who is suspected of committing theft (California Penal Code section 490.5.)

#### 1. Menlo Park Community Campus project updates

#### Demolition begins

- Heavy demolition at the Menlo Park Community Campus project site begins on September 16. The senior center and community center buildings will come down September 16 and 17. The pool and pool house will be demolished the week of September 27. The demolition and grading work will continue through October to prepare the site for construction of the new facility.
- A construction notice<sup>1</sup> to nearby residents was distributed in May 2021 by the contractor, Level 10
  Construction. Starting September 16, nearby residents may see jackhammering and increased truck
  traffic to the site. Work will only take place during approved work hours and access to Kelly Field
  and Beechwood School will be maintained. Level 10 Construction is working closely with
  Beechwood School representatives to keep them informed and mitigate impacts to the school
- The project website<sup>2</sup> has been updated to help keep the public informed about demolition activities.
   Demolition activities will generate some noise, vibratory and dust impacts to the surrounding area.
   Noise will comply with the City of Menlo Park noise ordinance for construction projects and dust will be mitigated by using the appropriate amount of water to spray active work areas
- Demolition will proceed in such a way as to repurpose and recycle usable building materials to the
  greatest extent feasible. For example, all concrete will be ground and recycled-in-place as
  underlayment in the new facility and parking area. All steel will be sent out to be re-smelted into new
  steel. All building materials will be sorted, tracked, and reused/recycled in accordance with the city's
  zero waste policies. Trees marked for preservation will be carefully protected.

#### Interim services

During construction of the new Menlo Park Community Campus facility:

- The Belle Haven Youth Center has temporarily relocated to a portable facility situated at the western end of the Kelly Park parking area
- The Menlo Park Senior Center has temporarily relocated to the Arrillaga Family Recreation Center with additional space in the Main Library
- Some recreation classes previously provided at the Onetta Harris Community Center have temporarily relocated to space in the Belle Haven Branch Library; additional recreation programs continue to be available at Arrillaga Family Recreation Center and Gymnasium.
- Aquatics programs continue to be available at Burgess Pool
- The existing Kelly Park athletic field, track, restrooms, tennis courts, and basketball courts will remain in place and accessible to the public throughout the project.

#### New facility

The Menlo Park Community Campus will include a new recreation center, gymnasium, senior center and dining hall, afterschool care center, fitness center, aquatics center, branch library, teen space,

maker space, and community meeting rooms, among other features and amenities. The new facility will be all-electric and will include solar panels to generate renewable energy to be used onsite and is being constructed to standards that will allow it to achieve designation as an emergency shelter. The new facility is scheduled to open in 2023.

- 2. <u>Commission work plan submittal to City Council</u>. The City Council tentative agenda calendar has been updated, and the Parks and Recreation Commission work plan submittal has been rescheduled to the regular City Council meeting on November 9, 2021.
- 3. <u>Personnel activity report</u>. The City Council on September 14, 2021 received a report outlining the status<sup>3</sup> of active, pending and yet-to-be prioritized recruitments, including several positions in the Library and Community Services department.
