- Youth Advisory Committee (YAC) created by City Council action in December, 2019
- YAC members are high school students who attend schools in Menlo Park or are residents of Menlo Park
- YAC is an advisory group to the Parks and Recreation Commission
  - Advises City staff and PRC on
    - Activities, events, programs
    - Current issues of interest to youth and youth trends
- Currently 14 teens serving on YAC

# **BACKGROUND**

- The City Council in 2016 approved the Information Technology Master Plan (ITMP)
- The ITMP rated the current registration management platform, eGov as "not optimal," and recommended replacement
- City Council authorized the implementation of a new platform,
   PerfectMind, on March 8, 2022
- Staff recognizes that not all residents are comfortable or familiar with online self-service registration systems, and for this reason will continue to provide live telephone and in-person registration support, paper-based documents and information, and training and technical support to residents as needed to ensure that all community members have equitable access to the city programs and resources.





# REGISTRATION MANAGEMENT PLATFORM

- Used by the public to:
  - Find and register for classes and events
  - Schedule and/or reserve City facilities like picnic areas, tennis courts, athletic fields, and meeting rooms
  - Submit applications and upload documentation
  - Pay fees and manage account profiles
- Used by staff to:
  - Process and account payments
  - Manage registrations, scheduling, and reservations
  - Track and analyze program data
  - Maintain user accounts
  - Integration with other City systems (Finance, IT)





# **FEATURES AND CONSIDERATIONS**

- Intuitive interface, mobile-friendly
- Ability for users to update and link family member profiles
- Notifications by email or text message
- Robust field, field and class reservation management
- Dedicated childcare enrollment module
- Sport league management tools
- Point-of-sale functionality for drop-in classes and open gym hours
- Flexible and powerful back-end reporting and data analysis
- Detailed account management and communication tools
- Other municipalities that use PerfectMind include: Oakland, Walnut Creek, Sausalito, Santa Rosa, Saratoga, Los Gatos





# **REVIEW PROCESS**

- City Council approved the ITMP recommending a new platform
- Project implementation team comprised of staff from Library and Community Services, Information Technology, Finance, and the City Manager's Office
- Other municipal jurisdictions provided recently completed analyses and evaluations of the platforms they are using
- Six vendors responded to a request for quotes and made presentations to a multidisciplinary team from recreation, child care, library, IT and finance
- Four potential vendors were moved forward to a second round of more detailed demonstrations
- PerfectMind was identified as the preferred software service provider on the strength of its platform's overall user-friendliness, flexibility, functionality, technical support, customer satisfaction reviews and references, and predictable flat-fee pricing model
- City Council authorized PerfectMind on March 8, 2022

#### Recommendation

That the Commission review and recommend a work plan for 2022-23.

### **Policy Issues**

City Council Policy CC-19-004 was adopted in 2019 to establish the procedures, roles and responsibilities of Council-appointed advisory bodies. The policy requires that each Commission submit an annual work plan to the City Council for approval, and that the work plan be recommended by a majority of the Commission's members.

### **Background**

Advisory body's work plans serve as a useful tool for both the advisory body and the Council to ensure that the work plan reflects the vision, mission, or priorities of the Council. Work plans are annually finalized by advisory bodies, then presented to City Council for direction and approval. Advisory bodies annually report out back to the City Council on progress toward the work plan and goals.

The Parks and Recreation Commission is charged with advising the City Council on matters related to City programs and facilities dedicated to recreation. This general charge includes advising on:

- Adequacy and maintenance of such facilities as parks and playgrounds, recreation buildings, facilities, and equipment.
- Adequacy, operation, and staffing of recreation programs.
- Modification of existing programs and facilities to meet developing community needs.
- Long range planning and regional coordination concerning park and recreational facilities.

The COVID-19 pandemic and the subsequent disruptions to advisory body meetings have led to a delay in developing and approving the Parks and Recreation Commission's (PRC's) work plan - the most recent approved PRC work plan covered the years from 2018-2020.

The PRC formed a work plan subcommittee in October 2021. The full PRC finalized the work plan on January 26, 2022. The work plan was presented to the City Council on February 8, 2022 but was not approved at that time.

#### **Analysis**

Staff recommends that the Commission review and update the work plan the PRC previously approved on January 26, 2022, in preparation for re-submitting it to the City Council at a future date to be determined.

# Parks and Recreation Commission Goals

- 1) Facilitate the goals laid out in the 2019 Parks and Recreation Master Plan.
- 2) Provide high quality programs and services for Menlo Park residents.
- 3) Maintain, upgrade, and expand city parks and facilities.
- 4) Enhance public awareness and engagement.
- 5) Include diverse community perspectives.
- Prioritize accessibility, safety, and sustainability.

# **Specific Examples**

- 3) Review the pickle ball court additions.

- 6) Develop strategies to mitigate the risks of off-leash dogs harming children.

- 7) Provide high quality and inclusive programs and services that meet the diverse and changing needs of all Menlo Park residents and neighboring communities.
- 8) Ensure City Parks and Community Facilities are well-maintained, upgraded and/or expanded to improve accessibility and usage by a diverse population, while promoting sustainable environmental design and practices.
- 9) Improve class and program offerings, venues, partnerships and sponsorships to increase the quality and accessibility of educational, recreational, sporting, artistic, and cultural programs in the City of Menlo Park.
- 10) Support initiatives, partnerships and projects that intersect with the City's Park and Community Services resulting in well-coordinated efforts to meet the needs of residents.
