

DEPARTMENT STATISTICS REPORT ENHANCEMENTS FOR 2025



- Marketing and outreach
 - The statistical report now includes email engagement data on Library and Community Service's weekly newsletter
- Senior center themed lunch events
 - The report now includes themed lunch events at Menlo Park Senior Center, along with attendance counts for each event.
- Library circulation corrections
 - Staff detected and corrected a duplication in circulation statistics reporting procedures
 - Approximate 10% over count (5,000-7,000 items per month) due to duplicate counts
 - Statistics have been retroactively corrected





LIBRARY COMMISSION RECRUITMENT

- One vacancy on the Library Commission for a term expiring on April 30. 2027
- City Council is set to consider applications and potentially make appointments tentatively on Feb. 25.

CITY COUNCIL PRIORITY SETTING WORKSHOP

- Last year's top 4 priorities: 1) Climate action; 2) Emergency and disaster preparedness; 3) Housing; 4) Safe routes



FALL 2024 CUSTOMER SATISFACTION SURVEY



- LCS issues a customer satisfaction survey to each user at the end of each season via email
- Information helps access the quality of classes and customer service and identify areas for improvement
- The Fall 2024 survey garnered significant engagement
 - 140 participants, 2087 responses, and 87 comments
 - Feedback on overall experience, quality of instruction, registration process, facility conditions, and type class involved in
- Takeaways include:
 - Overall satisfaction with customer service was high 85-90% reporting "very satisfied" or "somewhat satisfied" for approachability, helpfulness, courtesy, and professionalism
 - Responses of "very satisfied" in the areas of participant safety (89%) and facility cleanliness and equipment quality (83%)
 - 81-88% of respondents were "very satisfied" with class instructor's knowledge, delivery style, content, and environment created





GREEN BUILDING AWARD

- The Belle Haven Community Campus was awarded the 2025 Green Building Honorable Mention from Sustainable San Mateo County and the American Institute of Architects' San Mateo County Chapter
- This all-electric facility runs on on-site solar power, backed by battery storage for resilience during outages
- Generates more power than it uses while cutting typical energy consumption by 55%
- Extensive EV charging makes it easier for residents to access community resources while reducing vehicle trips
- All-electric design also helps improve local air quality by eliminating the need for natural gas.





CITY COUNCIL – CHANGE IN BELLE HAVEN POOL HOURS (INFORMATION REPORT)

- Report received on February 11 based on PRC recommendations from January 22
- Temporarily suspend minimum operating hours required
- Change in hours was implemented on Feb 14 (Attachment D)



SYNTHETIC/NATURAL TURF -PRELIMINARY RESEARCH



- Staff are researching findings to compare benefits and drawbacks of synthetic and natural turf
- A study from April 2024 concluded that there is not significant difference in chemical exposure between players on synthetic turf and natural grass turf (Environmental Protection Agency, Center for Disease Control, and Agency for Toxic Substances and Disease Registry)
- Synthetic turf installation may be connected to environmental concerns that could later impact human life (California Department of Toxic Substances)
- Synthetic Turf Council has emphasized the benefits of synthetic turf in terms of extended playtime, water conservation, and consistent playing conditions
- Mixed preferences from community input during previous discussions regarding Nealon and Kelly Park weight the pros and cons of synthetic turf
- Staff to continue research tentative report to PRC in June

Regular Business: Review draft community survey: library and

recreation programs and facilities

Recommendation

Staff recommends that the Parks and Recreation Commission (PRC) review and provide feedback on a draft community survey to seek Menlo Park resident input on library and recreation programs and facilities (Attachment A).

Policy Issues

The PRC advises the City Council on matters related to City programs and facilities dedicated to recreation.

Background

The Library and Community Services Department (LCS) periodically surveys residents to get feedback on the programs and services offered by the department.

On Sept. 13, 2022, City Council reviewed the results of a citywide survey of residents containing feedback and suggestions for LCS department services and programs, with particular focus on informing the planning of programs and services in the new Belle Haven Community Campus (Attachment B.)

On Mar. 18, 2024, the Library Commission (LC) reviewed the results of a citywide survey of residents containing feedback and suggestions for library book collections to help inform the planning of an opening day book collection at the new Belle Haven Library at Belle Haven Community Campus (Attachment C.)

On Nov. 12, 2024, City Council reviewed the results of a citywide survey of residents containing feedback and suggestions for programs and services at city-run preschools (Attachment D.)

On Nov. 20, 2024, the PRC reviewed the results of a citywide survey of residents containing feedback and suggestions for programs and services at City-owned aquatic centers (Attachment E.)

On March 17, 2025, the LC reviewed the draft community survey in Attachment A and offered suggestions for minor changes, including: add options for makerspace, work/study spaces, large gathering spaces, and activities for young children along with storytimes; reduce number of options about books to make room for the added options; add options for dog parks (Attachment F.)

Analysis

Library and recreation programs draft survey

The draft survey in Attachment A is intended to gain insight from residents about their needs and

preferences related to a wide array of LCS departmental programs, services, and facilities. The draft survey emulates the structure and many of the questions in the 2022 recreation and community programs survey so as to provide the ability to make apples-to-apples comparisons of past survey responses to the current survey responses. The draft survey in Attachment A does not include questions related to aquatics or preschools because those program areas recently were the subjects of detailed citywide surveys. In their place, new questions are included in the draft survey primarily focused on resident satisfaction with and suggestions for library and recreation facilities operated by the City of Menlo Park, including parks. Free text responses provide ample opportunities for residents to provide additional detail or context, make suggestions, and/or provide feedback in areas not covered by the provided questions.

Next steps

The survey is planned to open to the public tentatively on April 5 and close May 4. It is proposed that the survey be distributed in similar fashion as previous citywide surveys, which have proved effective in gaining substantive response rates from all neighborhoods across the City in the past. The survey is planned to be distributed in English and Spanish via multiple formats and distribution points including electronic, paper, and in-person at LCS facilities and with additional assistance from community partners. The survey results are planned to be presented at the joint PRC/LC meeting tentatively on May 28.

Impact on City Resources

As an advisory body to the City Council, the PRC does not authorize resource allocations nor direct the work of City staff. City budget and personnel authorizations are the sole purview of the City Council. Directing the work of City staff is the sole purview of the city manager and/or their City staff designees.

Environmental Review

This report is not a project within the meaning of the California Environmental Quality Act (CEQA) Guidelines §§ 15378 and 15061(b)(3) as it will not result in any direct or indirect physical change in the environment.

Public Notice

Public notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting.

City staff recommends that the Parks and Recreation Commission (PRC) review and provide feedback on the statistics and recent activities in the Library and Community Services (LCS) department outlined in this report.

Policy Issues

As a duly appointed advisory body to the City Council, the PRC is charged with advising the City Council on matters related to City programs and facilities dedicated to recreation.

Background

LCS provides a wide range of lifelong learning and recreational opportunities for Menlo Park residents of all ages, abilities, and lived experiences. Programs and facilities include public libraries, recreation and sports, early childhood education, after-school programs, summer youth camps, older adults (senior) services, athletic fields and courts, community events, and aquatics.

Analysis

February 2025 statistics

LCS collects statistics related to department activities. These data help to inform decision-making and improve services to the community. Monthly statistics for February 2025 are provided in Attachment A.

Aquatics program update

City Council held a public hearing Mar. 11 to consider proposed changes to aquatics fees in the master fee schedule and a proposed amendment to the aquatics operator agreement (Attachment B). City Council provided feedback on the proposals, and directed staff to return with additional information. Staff anticpates returning to City Council with proposed aquatiucs fees changes and a proposed amendment of the aquatyics agreement tentatively April 15.

Upcoming community events

The LCS department hosts and organizes free community events for Menlo Park residents of all ages and interests to enjoy. Notable upcoming events include:

• Community resource fair. Community members are invited for an engaging and informative resource fair for residents in the Belle Haven neighborhood and Menlo Park overall. Participants will enjoy delicious food, light entertainment, and an interactive atmosphere with local agencies and community groups providing information and resources for strong and vibrant neighborhoods. Saturday, March 29, from 11

- a.m. to 2 p.m. at Belle Haven Community Campus (Attachment C).
- Seed swap. The City of Menlo Park will host a seed swap event on March 29 from 10 a.m. to noon in the Menlo Park Library rear courtyard. The seed swap offers a chance for gardeners to exchange unused seeds with other gardeners. All skill levels are welcome, from beginner to expert. Bringing seeds is not required to participate. Seeds should be clean, dry, and packaged in small quantities for distribution with labels that list the plant name or variety. The seed swap event is a program of the City of Menlo Park Seed Lending Library, with funding support from Menlo Park Library Foundation (Attachment D).
- Egg Hunt– advance tickets required. On April 19, from 10 a.m. 1 p.m., the City of Menlo Park will hold its annual Spring Festival and Egg Hunt. The festival will feature a free petting zoo, photos with the big bunny, children's crafts, and related attractions. Attending Spring Festival is free and requires no ticket or registration; however, Egg Hunt will require advance registration to enter. Advance tickets are available to City of Menlo Park residents at no charge (limit one ticket per resident child) and \$5 per child for non-residents. On March 22, Egg Hunt tickets became available on a first-come, first-served basis while supplies last (Attachment E).

Impact on City Resources

As an advisory body to the City Council, the PRC does not authorize resource allocations nor direct the work of City staff. City budget and personnel authorizations are the sole purview of the City Council. Directing the work of City staff is the sole purview of the city manager and/or their City staff designees.

Environmental Review

This report is not a project within the meaning of the California Environmental Quality Act (CEQA) Guidelines §§ 15378 and 15061(b)(3) as it will not result in any direct or indirect physical change in the environment.

Public notification was achieved by posting the agenda, with the agenda items being listed, at least 72 hours prior to the meeting.
