2. Study Session/Kenneth Rodrigues and Partners/4085 Campbell Avenue: Request for a study session for a proposal to demolish 11,647 square feet of an existing 55,637-square-foot, two-story building at 40 Scott Drive in the M-2 (General Industrial) zoning district. The building is currently occupied by a fitness club and general office use. The proposed demolition would completely remove the second story of the building. The remaining 42,054-square-foot, one-story building would be remodeled for use by a new fitness club, and is proposed to be addressed 4085 Campbell Avenue. Time Limit: Members of the public will have **three** minutes and applicants will have **five** minutes to address an item. Please present your comments clearly and concisely. Exceptions to the time limits shall be at the discretion of the Chair.

Use of Microphone: When you are recognized by the Chair, please move to the closest microphone, state your name and address, whom you represent, if not yourself, and the subject of your remarks.

DISORDERLY CONDUCT: Any person using profane, vulgar, loud or boisterous language at any meeting, or otherwise interrupting the proceedings, and who refuses to be seated or keep quiet when ordered to do so by the Chair or the Vice Chair is guilty of a misdemeanor. It shall be the duty of the Chief of Police or his/her designee, upon order of the presiding officer, to eject any person from the meeting room.
