### NOVEL CORONAVIRUS, COVID-19, EMERGENCY ADVISORY NOTICE

On March 19, 2020, the Governor ordered a statewide stay-at-home order calling on all individuals living in the State of California to stay at home or at their place of residence to slow the spread of the COVID-19 virus. Additionally, the Governor has temporarily suspended certain requirements of the Brown Act. For the duration of the shelter in place order, the following public meeting protocols will apply.

Teleconference meeting: All members of the City Council, city staff, applicants, and members of the public will be participating by teleconference. To promote social distancing while allowing essential governmental functions to continue, the Governor has temporarily waived portions of the open meetings act and rules pertaining to teleconference meetings. This meeting is conducted in compliance with the Governor Executive Order N-25-20 issued March 12, 2020, and supplemental Executive Order N-29-20 issued March 17, 2020.

# Agenda item C1

## Lynne Bramlett, Resident

The four District 1 properties that you are discussing today all lie in an earthquake liquefaction zone. The property at 1467 Chilco Street lies in a FEMA Flood zone. While I am putting my comments in under C1, they apply to all properties you will discuss.

Liquefaction takes place when loosely packed, water-logged sediments at or near the ground surface lose their strength in response to strong ground shaking. Liquefaction occurring beneath buildings and other structures can cause major damage during earthquakes.

Even a 6.0 earthquake can cause liquefaction. Scientists have studied the faults in California extensively and determined that the Hayward fault is probably the most dangerous. It has a 31.7% chance of rupturing in a 6.7 magnitude earthquake or greater in the next 26 years, and the Bay Area has a 63% chance of having at least a magnitude 6.7 earthquake in the same time period.

At a May 2018 Council study session, the USGS updated Council as to the probable risk to Menlo Park of a 7.0 magnitude earthquake on the Hayward fault. This scenario is referred to as the "HayWired Scenario." The impact will be felt the most in District 1 and we have yet to mitigate for the probabilities. I am putting them into a short "fact sheet" (that I will also get reviewed by the USGS) to help these garner more mitigation focus.

ASK #1: MP needs building codes aimed at reducing hazard risk when building in a known hazard zone, such as liquefaction or flood risk. All of MP faces some hazards.

### Local Hazard Mitigation Plan Update

The County of San Mateo is updating its Local Hazard Mitigation Plan on a fast-track process that started in Feb and will end by August 31, 2021. MP will be updating its 2016 annex and Brian Henry, Assistant Public Works Director, is the designated MP contact to the County planning process. FEMA has provided extensive grant money for mitigation purposes and the County-led process stresses that all projects are to be written in ways for which grant money exists. This process offers much potential to re-shape MP positively towards the current Council's of a more equitable and livable MP for all. (Please consider formally writing and agreeing on a vision, along with phases to get there. That would help start a needed overall strategic planning process.)

Ask #2: The MP Update to Its Local Hazard Mitigation Plan is a golden opportunity to broaden the approach into one that protects the whole community and that incorporates other planning processes. For example, you could include the Climate Action Plan, Housing Element Update, City Council's Goal-setting process and Water Management Plan

### Brief summary of Portland objectives:

While updating this plan, the plan authors focused on incorporating community needs to advance the city's overall vision for equity. The steering committee examined which hazard mitigation activities could also further other community goals by engaging a broad section of the community in the plan process, and by using an equity lens to evaluate all proposed mitigation actions. The MAP sought to build on other planning work; among the plans reviewed for this update project were the "2015 Climate Action Plan", "Portland Plan", "Public Health Plan", "Capital Improvement Plan", "Growth Management Plan", "Transportation Systems Plan", and various volcano-related interagency coordination plans. As part of the project, city bureaus were asked to identify codes, plans, and programs that provide opportunities for advancing shared goals, so these resources could be listed as mitigation actions in the MAP.
